# IV. Approval of Regular and Executive Session Meeting Minutes – May 9, 2018

Motion to approve the minutes of the May 9, 2018 meeting was made by Mayor DiMaria. It was seconded by Mayor McLeod and unanimously approved. Motion to approve the Executive Session minutes of the May 9, 2018 meeting was made by Trustee Prigge. It was seconded by President Patterson and unanimously approved.

# V. President's Report – Arlene Juracek, NWMC President and Mayor, Village of Mount Prospect A. September NWMC Board Meeting Presentation – Nicor Energy Smart and North Shore Gas rebate programs

President Juracek introduced Nicor's Pat Eaves and Marvin Anaya who made a presentation on the Nicor Energy Smart rebate program for business and commercial sectors. North Shore Gas representatives Cate York also attended the meeting to share their energy rebates and programs for residents.

# B. FY 2017-2018 NWMC Annual Report

President Juracek advised that the FY 2017-2018 NWMC Annual Report, which highlights the past year's accomplishments as well as organizational information including the NWMC leadership, committees, membership and staff, was released to the membership on August 10. She requested that members share the document with their elected officials and staff.

#### C. Metropolitan Mayors Caucus Executive Committee Appointment

President Juracek reported that the Executive Board recommended that the membership appoint Deerfield Mayor Harriet Rosenthal as the delegate and Mount Prospect Mayor Arlene Juracek as the alternate delegate to the Metropolitan Mayors Caucus (MMC) for FY 2018-2019. Motion to approve the recommendation was made by President Darch. It was seconded by Mayor McLeod and unanimously approved.

#### D. NWMC October 23 Fall Surplus Vehicle & Equipment Auction

Mr. Fowler noted that the NWMC Surplus Vehicle and Equipment Auction will be held at America's Auto Auction in Crestwood and encouraged members to participate.

#### E. SPC to Host Vendor Booth at IML Conference

Mr. Fowler announced that the Suburban Purchasing Cooperative (SPC) will host Booth #302 at the upcoming Illinois Municipal League annual conference and said six key vendors of the Cooperative would be present, including: Call One (telecommunications); Currie Motors (Ford and Chevy vehicles); Foster Coach (Type I and Type III Ambulances); Fire Service, Inc. (Type III Ambulance); Laport (janitorial supplies); and, Standard Equipment (street sweepers and sewer cleaning trucks). He said the exhibit hall will be open on Thursday, September 20 from 2:00 p.m. to 5:00 p.m. and on Friday, September 21 from 10:00 a.m. to 5:00 p.m. and encouraged members to visit the expo.

# VI. Priority Issues

# A. Legislative Committee – Dan DiMaria, President, Village of Morton Grove, Co-Chair and Lawrence Levin, President, Village of Glencoe, Co-Chair

# 1. 2018 Call for Legislative Initiatives

Mr. Bury reported that the Legislative Committee issued a call for legislative initiatives for consideration as part of the 2019 Legislative Program. He advised that since the September Legislative Committee meeting was postponed until October, submittals were still welcome.

# 2. Pension Fund Consolidation Update

Mr. Fowler introduced Illinois Municipal League (IML) Executive Director Brad Cole, who presented the public safety pension consolidation proposals that will be considered by the IML Board of Directors at their September 20 meeting. He said the IML Board was scheduled to select a single proposal to advance and that IML would be willing to spend \$1 million for a media/outreach plan to support the effort. He said public relations proposals were received from MAC Strategies and Serafin and Associates. Mr. Fowler noted that the IML packet was sent to the Pension Fairness for Illinois Communities Coalition and to the NWMC Board, asking for feedback prior to the IML Board meeting.

Mr. Frenzer stated that Option #2 should be the preferred option as it promises to provide the most long term benefit. Mr. Lockerby also stated his preference for Option #2. President Juracek noted that Option #7 is not a long term solution. Mr. Cole noted that Option #7 would save tens of millions of dollars in the near term and that a number of IML members need immediate relief from their pension obligations.

# B. Transportation Committee – William McLeod, Mayor, Village of Hoffman Estates, Co-Chair and Rodney Craig, President, Village of Hanover Park, Co-Chair

#### CMAP Surface Transportation Program (STP) Project Selection Committee

Mr. Jackson and Mr. Klingenstein provided an update on the activities of the STP Project Selection Committees. They reported that, at recent meetings, the committee discussed revised drafts for Shared Fund and Active Program Management policies. The NWMC and Northwest Council of Mayors sent letters outlining additional questions and concerns. Mr. Bury said that he and President Darch participated in an August 30 meeting with CMAP Executive Director Joe Szabo where additional proposals were exchanged. Mr. Rummel thanked staff for their efforts on this issue.
