B. Finance Committee – Ray Keller, NWMC Treasurer and Manager, Village of Lake Zurich, Chair

1. Employee Assistance Program Contract Extension

The Executive Board and Finance Committee recommend approval of the fourth of four (4), oneyear contract extensions of the NWMC Employee Assistance Program contract with Morneau Shepell. The extension would run from May 1, 2021 through April 30, 2022 with no increase in the annual rate.

2. NWMC Surplus Vehicle & Equipment Auction Agreement

The Executive Board and Finance Committee recommend offering the first of four possible, oneyear contract extensions for Auctioneer Services with America's Auto Auction (AAA) from February 15, 2021 through February 14, 2022 with the following changes:

- Contractor shall deduct 9% of the gross amount of the sale (up from 8%);
- \$25 per no sale run (previously no charge);
- Wash & vacuum fee of \$45 per vehicle (up from \$25);
- Full detail services for a fee of \$100 per vehicle (up from \$90); and
- Transportation rate of \$2.50 per Google Mile, minimum \$50 per vehicle (previously \$1.50 per Google Mile, minimum \$35).

The current agreement for Auctioneer Services with AAA expired on February 14. Staff will provide information on proposals solicited from other auction providers. The proposed auction dates for 2021 are April 20, July 20, and October 19.
