#### 2. Pension Fairness for Illinois Communities (PFIC) Coalition Update

The contract extension would run from May 1, 2024 to April 30, 2025. Program vendor TELUS Health has requested a 4% rate increase as part of the contract extension. The Executive Board and Finance Committee further recommend a corresponding 4% increase in the charge to participants to cover the increase.
