A. NWMC By-Laws Update (Attachment C)

One of the items in the FY2021-2022 NWMC Work Plan is a review of the NWMC By-Laws and other foundational documents. Staff initiated the required 30-day review period by presenting proposed changes to the By-Laws in January. The Executive Board recommends approval of the updated By-Laws. Priority Issues

A. Legislative Committee – Tom Dailly, President, Village of Schaumburg, Co-Chair and Dan Shapiro, Mayor, Village of Deerfield Co-Chair

1. Legislative Update

Due to COVID and weather concerns, the General Assembly has only been able to meet in person once despite having a full schedule. During this time, many of the scheduled virtual committee hearings were cancelled. Governor Pritzker delivered the State of the State/Budget address on February 2 from outside the Capitol. Staff will report on the budget address, legislative activities of the General Assembly and expectations going forward.

2. 2022 NWMC Legislative Program Rollout Meetings

3. Bill Positions (Attachment E)

The Executive Board and Legislative Committee recommend approval of the positions on the attached list of bills. The deadlines to introduce substantive bills were January 21 in the Senate and January 28 in the House.

B. Finance Committee – Anne Marie Gaura, Manager, Village of Lincolnwood, Chair

1. NWMC Surplus Vehicle & Equipment Auction Agreement

The Executive Board and Finance Committee recommend approval of the second of four possible, one-year contract extensions for Auctioneer Services to America's Auto Auction. The extension would run from February 15, 2022 through February 14, 2023. The current agreement expires on February 14. Contract terms shall remain the same. The proposed auction dates for 2022 are April 19, July 19 and October 18.

2. NWMC 401A Plan Document Update Adoption (Attachment F)

The Conference's 401A Plan through ICMA-Retirement Corporation (dba MissionSquare Retirement) requires a review process every six years to maintain IRS compliance. The Executive Board and Finance Committee recommend approval of the updated Governmental Money Purchase Plan and Trust Adoption Agreement by March 15, 2022 to finalize the process. *Action Requested:* Approve recommendation

VII. Northwest Council of Mayors Technical Committee – Karen Darch, President, Village of Barrington, Chair

1. STP-L Methodology Changes – Northwest Council of Mayors (Attachment G)

At their January 28 meeting, the Northwest Council of Mayors Technical Committee approved the staff and Working Group's recommendations to approve three changes to the Northwest Council of Mayors STP-L Handbook. These changes include removing the policy prohibiting cost increase requests for Phase II engineering, removing the requirement for requests to wait until April of each year for submittal, and adding additional prioritization for construction phases when considering multiple requests. These changes are outlined in the attached memo. The Northwest Council of Mayors Technical Committee recommends approval by the Northwest Council of Mayors. *Action Requested:* Approve recommendation

2. Cost Change Requests – Northwest Council of Mayors (Attachment H)

At their January 28 meeting, the Northwest Council of Mayors Technical Committee approved staff's recommendation to approve two cost changes from members of the Northwest Council of Mayors. These requests are listed below:

- a. <u>Village of Arlington Heights</u> request for \$35,000 for ENG II in FFY 2022 for the Wilke Road project. Staff recommends approval to place an item on the February 9 NWMC Board meeting agenda for approval by the Northwest Council of Mayors.
- b. <u>Village of Streamwood</u> request for \$24,235 for ENG II in FFY 2022 for the IL 19/Bartlett Road project.

The Northwest Council of Mayors Technical Committee recommends approval by the Northwest Council of Mayors.

3. Functional Classification Change Requests – Village of Wheeling (Attachment I)

As part of the process for a roadway functional classification change, local agencies must include an approved resolution of support from their local Council of Mayors with their application to the Illinois Department of Transportation and the Federal Highway Administration. At their January 28 meeting, the Northwest Council of Mayors Technical Committee recommends approval by the full Northwest Council of Mayors of the attached resolutions for the following roadways in the Village of Wheeling:

- a. Lexington Drive from Lake Cook Road to McHenry Road
- b. East Manchester Drive from South Wolf Road to South Milwaukee Avenue
- c. East Strong Street from North Wolf Road to North Milwaukee Avenue
