Dear Mr. Sepiol,

This letter is to inform you that the Suburban Purchasing Cooperative's Governing Board has approved the second extension of SPC Contract #192 for Electrical Lighting, Data/Communication, Networking, Wireless, Security and Related MRO Supplies and Services to GraybaR, St. Louis, MO by piggybacking onto the Omnia Partners Contract #EV2370 awarded by lead agency, the City of Kansas City, according to the State of Illinois statues, 525/2 from Ch. 85, par. 1602. (Governmental Joint Purchasing Act), which authorizes any governmental unit may purchase personal property, supplies and services jointly with one or more other governmental units. This extension runs from February 1, through January 31, 2025. It may then be renewed annually for the duration of the contract, which expires January 31, 2029.

GraybaR will pay an administrative fee to the SPC of 1% from dollar one spent, with the exception of the following municipalities:

GraybaR will submit Excel spreadsheets on a quarterly basis on the SPC fiscal year of May 1 through April 30, recording all sales and administrative fees by purchasing agency. Payments and reports must be received within 30 days of the end of each fiscal quarter upon. Fiscal quarters are defined as:

May 1 through July 31 – payment due by August 30
August 1 through October 31 – payment due by November 30
November 1 through January 31 – payment due by February 28
February 1 through April 30 – payment due by May 31


GraybaR will handle all billing. The agreed upon SPC Administrative Fees shall be paid directly by the vendor to the NWMC on behalf of the SPC on a quarterly basis. Under this Agreement, all Suburban Purchasing Cooperative members, non-profit and "public agency" participants will be grouped under one Master SPC Account to aggregate all purchases.

All public agencies as defined by the Illinois Governmental Joint Purchasing Act, as well as not-for-profit agencies that qualify under Section 45-35 of the Illinois Procurement Code, are eligible to participate in SPC joint purchasing programs. The term "public agency" shall mean any unit of local government as defined in the Illinois Constitution of 1970, any school district, any public community college district, any public building commission, the State of Illinois, any agency of the State government or of the United States, or of any other State, any political subdivision of another State, and any combination of the above pursuant to an intergovernmental agreement which includes provisions for a governing body of the agency created by the agreement.


