IV. Approval of Meeting Minutes – February 13, 2019

Motion to approve the minutes of February 13, 2019 was made by President DiMaria. It was seconded by President Frum and unanimously approved.

V. President's Report – Arlene Juracek, NWMC President and Mayor, Village of Mount Prospect A. NWMC Annual Gala

President Juracek reported that Save-the-Date postcards and sponsorship information was sent last week for the annual Gala, scheduled for Wednesday, June 19. She advised that it will be held at Victoria in the Park in Mount Prospect. Mr. Fowler thanked President Juracek and Doreen Jarosz for negotiating a special deal for the Conference.

B. FY2019-2020 NWMC Officer Nominations

Mr. Fowler said that he emailed the FY19-20 NWMC Officer Nomination Form to the membership on Thursday, February 21 and has received five responses to date. He said that nominations are due back to him by Friday, March 15.

C. April 23 Surplus Vehicle & Equipment Auction

Ms. Dayan reported that the next NWMC Surplus Vehicle & Equipment quarterly auction will be held on Tuesday, April 23 at 2:00 p.m. at America's Auction, 14001 S. Karlov Avenue in Crestwood.

VI. Priority Issues

A. Legislative Committee – Dan DiMaria, President, Village of Morton Grove, Co-Chair and Lawrence Levin, President, Village of Glencoe, Co-Chair

1. Legislative Update

Mr. Bury reviewed the potential impacts from the state budget on local governments. He reported on bills of concern including SB 1675, HB 270, SB 1783 and SB 1532. He also reviewed public safety pension bills including HB 2678, HB 2679, HB 2680, HB3354 and HB 3013.

2. Legislative Positions

Mr. Bury reported that the Executive Board and Legislative Committee recommended positions on the bills included in the packet. Motion to approve the recommendation was made by President Frum. It was seconded by Mr. Norris and unanimously approved.

3. Recreational Cannabis Legalization Legislation

Mr. Bury reviewed highlights from the February 25 summit for municipal officials. The board discussed the concerns for local government, including local authority and law enforcement issues.

4. NWMC Legislative Days in Springfield

Mr. Fowler reviewed planned activities for the Conference's 2019 NWMC Legislative Days in Springfield scheduled for Tuesday, March 19 through Thursday, March 21.

B. Finance Committee – Ghida Neukirch, Manager, City of Highland Park, Chair NWMC Employee Assistance Program Contract Extension

Ms. Neukirch reported that the Executive Board and Finance Committee recommended approval of the second of four (4), one-year contract extensions of the Employee Assistance Program Contract with Morneau Shepell. She advised that the extension would run from May 1, 2019 through April 30, 2020 at a continuation of the current annual rate of \$23.50 per employee. Motion to approve the recommendation was made by President Levin. It was seconded by President Frum and unanimously approved.

C. Transportation Committee – William McLeod, Mayor, Village of Hoffman Estates, Co-Chair and Rodney Craig, President, Village of Hanover Park, Co-Chair

President Craig said that he just returned from Washington D.C. and reported on the activities of the National League of Cities Transportation Committee.

1. NWMC Multimodal Plan Member Community Staff Survey

Mr. Jackson provided an update on the NWMC Multimodal Plan community survey, which was distributed to mayors and managers of all NWMC member communities last week. He reported that the survey asks community staff to provide feedback on the priority corridors identified in the 2010 bicycle plan, as well as information on challenges faced by people walking, biking, and accessing transit in NWMC communities.

2. STP Shared Fund Bonus Point Allocations

Mr. Klingenstein gave an update on the process for allocating Council of Mayors bonus points for the Surface Transportation Program (STP) Shared Fund. He reported that each council has 25 bonus points that it can allocate to Shared Fund projects throughout the region, with 15 being the maximum number of points that can be assigned to a particular project. He said that the Northwest and North Shore Councils of Mayors are developing a methodology for allocating these bonus points to eligible projects.

VII. Consent Agenda

Motion to approve the consent agenda was made by President Levin. It was seconded by Mayor Hayes and unanimously approved.

VIII. Other Business

Mr. Bury updated the membership on the Buffalo Grove Fire Department pension hearing that took place on February 25.

IX. For the Good of the Order

President Juracek welcomed the new Lincolnwood Manager Anne Marie Gaura.

X. Next Meeting

President Juracek said that the next Board meeting will be held on Wednesday, April 10 at 7:00 pm in room 1604 at Oakton Community College.
