**COVID-Related Impact on Transportation Revenues (Attachment D)** 

NWMC communities have experienced significant declines in Motor Fuel Tax (MFT) revenue compared to the previous year along with delays in accessing line item funding through the Illinois Department of Commerce and Economic Opportunity's Build IL Bond Fund. Staff will review the results of a recent survey outlining the impacts of this situation on member infrastructure programs (see attached). Additionally, regional agencies, including Metra, Pace, the Regional Transportation Authority and the Illinois Tollway, are also facing tough decisions in their budget processes due to COVID-related revenue declines. Staff will provide a report.
