- Identified and advocated for transportation funding opportunities for our members.
- Expanded the Suburban Purchasing Cooperative and conducted the Supplier Showcase.
- Collaborated with the DuPage Mayors and Managers Conference and the region's councils of government on the Newly Elected Officials Workshop.
- Approved the FY25-26 NWMC Budget without a dues increase for the twelfth consecutive year.

These accomplishments would not have been possible if not for the hard work of our marvelous members, committee chairs, staff, consultants and regional partners. Thank you to the nearly 400 NWMC member elected officials, staff and other stakeholders who served on the organization's thirteen standing and ad hoc committees. LEGISLATIVE ADVOCACY



Key Legislation/Initiatives

- NWMC President and Hanover Park Mayor Rod Craig, Vice President and Libertyville Mayor Donna Johnson, Secretary and Buffalo Grove President Eric Smith met and discussed pending legislation and local government issues with House Speaker Emanuel "Chris" Welch.
- NWMC President and Hanover Park Mayor Rod Craig and Barrington Village President Karen Darch published letters to the editor on municipal pensions and transit reforms in the Chicago Tribune, Daily Herald and Crain's Chicago Business.
- NWMC members and staff gathered in Springfield for the annual NWMC Legislative Days. Twenty-one participants representing ten member communities advocated for municipal interests during meetings with key legislative leaders and legislators as well as attended Governor Pritzker's Budget Address.
- NWMC Executive Director Mark Fowler, on behalf of the Invest in Communities Coalition, testified before the
 House Personnel and Pensions Committee on the importance of maintaining municipal Tier 2 pension reforms.
 His testimony provided the history of Tier 2 pensions and emphasized the difference between the state and local
 pension systems regarding Social Security Safe Harbor concerns.
- Mr. Fowler also gave a presentation on the history of pension reform and pending legislation at the Illinois Government Finance Officer Association's 2025 Pension Institute Webinar Series.
- Administered the Pension Fairness for Illinois Communities Coalition, established a work plan and held partner
 meetings throughout the year, focusing on opposing the proposed erosion of Tier 2 and education on the Social
 Security Safe Harbor issue.

LEGISLATIVE ADVOCACY



- Established transit principles to guide the Conference's engagement on transit funding and governance legislation. Additionally, the Conference adopted a resolution supporting the protection of suburban municipal voices in transit governance and sustainable transit funding for the region.
- NWMC Leadership met with proponents of the Metropolitan Mobility Authority Act to exchange information and viewpoints.
- Issued an Action Alert during Veto Session requesting that members and partner Councils of Government contact legislators to remove police and fire Tier 2 pension changes from HB5909/SB3988.
- Partnered with the DuPage Mayors and Managers Conference on a joint public relations contract with Serafin &
 Associates and Yellow Box during the 2025 Spring legislative session, including a targeted digital media campaign
 focused on influencing key legislators on municipal pension issues.
- Staff published a comprehensive analysis of Governor Pritzker's proposed budget.
- Staff published thorough analyses of the Metropolitan Mobility Authority Act legislation (Senate Bills 3937/3938 and House Bills 5828/5829) and the Labor Coalition Transit Reform legislation (SB1938).
- Worked with the Invest in Communities Coalition led by the DuPage Mayors and Managers Conference to advocate for an increase in the Local Government Distributive Fund and in opposition to elimination of the Grocery Tax. Worked with partners to incorporate the Pension Fairness Coalition under the Invest in Communities banner.

LEGISLATIVE ADVOCACY

- Supported and successfully advocated for passage of Senator Julie Morrison's IDOT Local Government Portal bill (SB2129).
- Provided State Representative Tracy Katz Muhl with research on revenue constraints facing non-home rule municipalities.
- Staff monitored the work of the House Pension and Property Tax Relief Working Groups.
- Members participated in an Invest in Communities press event at Elmhurst University.
- Developed and forwarded messaging to members on proposed elimination of the Grocery Tax and Crime Free Housing Ordinances.
- Monitored legislation proposing to restrict local Crime Free Housing Ordinances.

Additional Advocacy/Activities

- The NWMC Legislative Committee held eleven meetings, led by committee co-chairs **Buffalo Grove Village President Eric Smith** and **Northfield Village President Greg Lungmus**.
- The NWMC Legislative Committee, staff and consultants tracked over 500 bills during the spring 2025 session.
- Staff published "Bills in Committee" emails during each session week, highlighting priority legislation in House and Senate committees with instructions for members to submit witness slips and/or take additional action.
- Staff developed factsheets on legislation threatening local zoning authority (HB 1813 & 1814) and firefighter paid family leave (HB 2490).
- Staff issued NWMC Action Alerts during the veto and spring sessions:
 - Opposing the elimination of suburban representation as part of northeastern Illinois transit governance
 - Increasing the Local Government Distributive Fund (LGDF)
 - Opposing the Deferred Retirement Option Plan (DROP) HB3765
 - Opposing Paid Family Leave for Firefighters legislation (HB2490)
 - Opposing Crime Free Housing Ordinance Prohibition (SB2264)
 - Opposing Tier 2 Public Safety Pension Enhancements
 - Opposing expansion of the "supervisor" definition in the Illinois Public Labor Relations Act
- The Conference published twelve NWMC Legislative Updates.
- The Conference extended its contract with Anderson Legislative Consulting to maintain a consistent presence in Springfield.
- NWMC members and staff attended the Illinois Municipal League's annual Lobby Day.



- Staff published a thorough analysis for the membership of the Metropolitan Mobility Authority Act and related legislation, which seeks to restructure the region's mass transit governance and increase funding.
- The Conference issued "Regional Transit Legislation Guiding Principles" which outline ideas to improve regional transit services and highlight the need for state investment.
- Barrington Village President Karen Darch presented the Conference's Guiding Principles during testimony to the Senate Transportation Committee and House Working Group on Transit.
- Members and staff attended all Senate Transportation Committee subject matter hearings on transit reform.
- Held eight meetings of the NWMC Transportation Committee, which was led by co-chairs Hanover Park Village
 President Rod Craig and Libertyville Mayor Donna Johnson. Key presentations and discussions included:

- The North Shore and Northwest Councils of Mayors approved their Surface Transportation Program Local (STP-L) programs for FY2025-2029. Seventeen projects totaling over \$35 million were approved for funding.
- The North Shore Council of Mayors began an update to its locally programmed Federal Surface Transportation Program (STP-L) fund methodology.
- Both the Northwest and North Shore Councils of Mayors participated in the Call for Projects for the regionally programmed Federal Surface Transportation Program-Shared (STP-Shared) funds.



- The North Shore and Northwest Councils of Mayors programmed and obligated over \$27.6 million in Surface Transportation Program (STP) funding for engineering, right-of-way acquisition and construction. The North Shore Council obligated over \$10.9 million in STP funds, while the Northwest Council obligated over \$16.7 million.
- Additionally, the Northwest and North Shore Councils obligated over \$3.1 million in Congestion Mitigation and Air Quality (CMAQ) and locally programmed Transportation Alternatives Program (TAP-L) funds.
- Coordinated meetings between IDOT Central Office and Municipal, COG, and Regional Agency staff.
- Highland Park Mayor Nancy Rotering and Mount Prospect Mayor Paul Hoefert served on the Chicago Metropolitan Agency for Planning Board of Directors.
- Arlington Heights Village President Tom Hayes, Barrington Village President Karen Darch, Northfield Village
 President Greg Lungmus, and Skokie Mayor George Van Dusen served on the Chicago Metropolitan Agency for
 Planning Council of Mayors Executive Committee.





SUBURBAN PURCHASING COOPERATIVE (SPC)

- Created and published the Suburban Purchasing Cooperative Joint Purchasing Newsletter. Each quarter, the newsletter will detail the latest information about the suppliers, products and services offered by the SPC.
- The SPC implemented all contracts via the Sourcewell/SPC Interlocal Agreement, providing member access to over 550 products and services via Sourcewell's national cooperative purchasing program.
- The SPC realized gross sales of approximately \$112 million.
- Through Q3, the SPC earned administrative fees of nearly \$275,000, of which over \$236,000 went to the NWMC.
- 596 vehicles were sold on SPC contracts.
- Hosted the SPC Supplier Showcase with 20 suppliers and 100 attendees. The event featured a Lunch & Learn presentation by Sourcewell that offered continuing education credits awarded to NIGP members.

- Promoted Granite Government Solutions as the sole SPC
 Telecommunications program provider and scheduled topical Granite Government Solutions webinars.
- Staff registered 5 new vendors on the SPC bidder list.
- Staff regularly updated the SPC program brochure and disseminated it and related marketing materials to the SPC's partner Councils of Government.
- In FY24-25, 262 unique entities participated in SPC joint purchasing programs; with the addition of the Sourcewell programs, the SPC reached over 700 entities.
- Executed a new agreement with Sourcewell.
