## Time to Respond to the Councils of Mayors 2027- 2031 STP-L Call for Projects

Time is running short to submit projects during the North Shore and Northwest Councils of Mayors Call for Projects for 2027-2031 Surface Transportation Program-Local (STP-L) funding. The [North Shore Call for Projects](#) will be open until Friday, December 19, and the [Northwest Call for Projects](#) will be open until Tuesday, December 30. Project selection methodologies and application documents are available on each Council's website.

The NWMC held a STP-L workshop last month where staff reviewed the Call for Projects timeline, STP-L funding overview and council-specific application requirements. A [recording of the workshop](#) can be found on the NWMC YouTube Channel. Additionally, the North Shore Council of Mayors hosted a

## Access to Transit Call For Projects Now Open, Featuring New Trail- Supportive Development Category

*From our partners at the Regional Transportation Authority (RTA):*

The call for projects is now open through Friday, January 16 for RTA's [Access to Transit program](#), which improves access to the regional transit system for people walking and biking, implementing recommendations from planning studies completed through the RTA's [Community Planning program](#). To date, Access to Transit has funded 51 projects in municipalities throughout the region for a total investment of \$23.8 million.

Eligible projects include ADA accessibility improvements, bicycle infrastructure, intersection improvements, sidewalk gap connections, wayfinding, and more. Newly eligible this year from [Senate Bill 2111](#) are Trail-Supportive Development infrastructure improvements that are located within one-quarter mile of a public trail and are designed to facilitate access to and use of public transit.

RTA staff are offering a virtual Open House session during which applicants can ask questions about the application process, about specific project ideas, and anything else related to the call for projects. Potential applicants can participate at any time during the Open House session on Wednesday, January 7, 2026 – 9:30 to 10:30 a.m. [Register here](#).

## **US DOT BUILD Grants Call for Projects Now Open**

The U.S. Department of Transportation (US DOT) Better Utilizing Investments to Leverage Development (BUILD) grant program is now open and accepting applications. BUILD is a competitive grant program, that provides funding for “planning or constructing surface transportation infrastructure projects that will improve safety; environmental sustainability; quality of life; mobility and community connectivity; economic competitiveness and opportunity including tourism; state of good repair; partnership and collaboration; and innovation.” Eligible projects include Title 23 federal-aid highways and bridges \$1.5 billion dollars in funding will be available, with awards ranging from \$5 million to \$25 million for urban capital projects. ## **CMAP Launches the Century Plan**

*From our partners at the Chicago Metropolitan Agency for Planning (CMAP):*

The father of urban planning and co-author of the visionary 1909 Plan of Chicago, Daniel Burnham, famously said, “Make no little plans.” A century later, regional leaders are embarking on the next BIG plan for this region.

Nearly 1,000 people, including state officials, mayors, and county board chairs, along with transportation, business, and civic stakeholders, came together to kick off The Century Plan — a shared, overarching vision for the seven- county region that will guide policies for transportation, the environment, and the economy for decades into the future. The Chicago Metropolitan Agency for Planning (CMAP) hosted a first-of-its-kind State of the Region event on November 4th to inspire and catalyze a regional initiative to shape the future. The gathering also celebrated CMAP’s 20th anniversary and two decades of regional planning progress.

Over the next two years, CMAP will engage with government, business, and civic groups, along with residents and communities to develop The Century Plan, with a targeted adoption by the CMAP Board and the MPO Policy Committee in fall 2027.

At the State of the Region event, which took place at the iconic Old Post Office in Chicago, guests got a first look at data trends that will help drive conversations around key quality of life issues, including housing and the economy, flooding and transportation, the region’s aging population, and more.

## **Where Would You Like To See New Rail Stations?**

*From our Partners at the Cook County Department of Transportation and Highways (DoTH)*

Please help the Cook County DoTH promote a survey by sharing the [attached flyer](#) with your members, which can also be accessed at [www.cookralsurvey.com](http://www.cookralsurvey.com). The survey will run through December 31.

The survey is part of a study DoTH is leading to investigate where additional transit rail stations should be considered along existing transit rail lines within Cook County. This effort is called the Rail Infill Station Study and is being conducted in partnership with CDOT, CTA, and Metra. The expected results of the study include a set of prioritized stations for the agencies and stakeholders to further investigate and develop, as well as a vision for how key stations may fit into both the local context and the broader transit network. Work on the study is expected to be completed in 2026.

Both CTA and Metra rail networks are being evaluated, and we are seeking input through the online survey from the general public and local and regional stakeholders. These survey results will help us better understand and prioritize opportunities for future rail stations. Social media posts and car card advertisements for the survey will begin appearing on CTA and Metra trains in the coming weeks so please be on the lookout for those as well. We also welcome COG and COM staff to complete the survey. Kindly limit to one response per organization or municipality.

## **I-290/I-88 Pace Express Feasibility Bus Study Second Survey**

*From our Partners at Pace Suburban Bus:*

Pace Bus is in the final stages of an I-290/I-88 Express Bus Study to explore potential transit opportunities within a five-mile radius of the Interstate 290 Eisenhower Expressway corridor and the I-88 Ronald Reagan Memorial Tollway. This study evaluates potential expressway-based bus services, including bus-on-shoulder operations, connecting key destinations such as the CTA Forest Park Blue Line Transit Center, the Oak Brook Center/Cermak-Butterfield corridor, and the Schaumburg/Woodfield region.

This feasibility study assesses the potential for faster and more efficient transportation options for commuters traveling between various west suburban locations and Chicago. The study explores the viability and demand for proposed I-290 and I-88 Pace Express service, which would offer limited-stop service, ensuring reduced travel times while maintaining key connections to major suburban hubs.

Designed to integrate seamlessly with Metra and CTA rail service, the proposed express service would provide a reliable, affordable alternative to driving, particularly during peak commute hours. The feasibility study analyzes various factors, including ridership demand, travel patterns, and operational logistics, to determine the most effective design for an express bus service. The study seeks to address growing demand for improved public transit options, enhancing accessibility and reducing congestion along the corridors. By providing an expedited service, the potential routes could significantly enhance mobility for residents, workers, and visitors who rely on public transportation for their daily commutes.

***Community input plays a vital role in finalizing the study's findings.***

Pace's collaboration with local stakeholders ensures that service meets the needs of commuters.

You are encouraged to participate in the upcoming public open house on Tuesday, December 9<sup>th</sup>, at the Howard Mohr Community Center, 7640 Jackson Blvd. - Forest Park, IL 60130 from 6 PM – 8 PM.

We seek your input on preliminary route and station concepts. At the open house, attendees can comment on proposed service plans, station locations, and connections to area communities like Oak Park, Oak Brook, Forest Park, and Schaumburg. A separate activity table for children will be provided, and families are welcome and encouraged to attend.

## Webinar: Safe Streets and Roads for All

*From our partners at the United States Conference of Mayors Local Infrastructure Hub:*

The Local Infrastructure Hub will be offering a new series of Workshops beginning in Fall 2025. Registration is open and dates will be confirmed at a later date. During a half-day workshop, participants will gain grant-specific guidance on high-value federal funding opportunities and learn how to navigate application requirements, align projects with funding criteria, and strengthen implementation readiness. Participants will also have access to office hours with subject-matter experts. The Safe Streets and Roads for All (SS4A) program provides funding to prevent roadway fatalities and serious injuries. Cities can use this funding to develop safety action plans, redesign high-risk corridors, or implement infrastructure improvements like sidewalks and crosswalks. ## 2026 Regional Transportation Plan: Refined Financial Forecasts and Project Evaluations

*From our partners at CMAP:*

CMAP continues to advance the [2026 Regional Transportation Plan \(RTP\)](#) through extensive research, data analysis, and public engagement.

To meet federal requirements for fiscal constraint, CMAP is developing long-range financial forecasts for the RTP to estimate baseline revenues and expenditures and identify additional reasonably expected revenues. Working with a [financial plan resource group](#), CMAP has refined transparent and accurate forecasting methods to guide investment priorities through 2050. A forthcoming **Financial Plan Risk Assessment** will evaluate key uncertainties and identify realistic and resilient mitigation strategies.

Through coordination with partner agencies, CMAP has identified 137 regional capital projects (RCPs) for possible inclusion in the RTP. [A draft RCP Benefits Report](#) summarizing the benefits that each proposed project offers to the region is now available. The RCP candidates can also be viewed in an [interactive map](#). CMAP will continue to update and refine this report through the end of the year.
