# Public Comment for Northwest and North Shore Councils of Mayors' STP-L Programs Now Closed

On June 30, the Northwest and North Shore Councils of Mayors Technical Committees closed the public comment period for their respective FFY 2021-2025 local Surface Transportation Programs (STP-L). Both Councils' Technical Committees will convene in August to consider public comments and vote to send their programs to the full Northwest and North Shore Councils of Mayors for approval.

#### FRA Grant Opportunity Aimed at Railroad Trespassing Suicide Prevention

The Federal Railroad Administration (FRA) has published a Notice of Funding Opportunity (NOFO) to make funds available for implementing suicide prevention projects. Since 2015, 1351 people have taken their lives by committing railroad trespass-related suicide. Railroad trespass-related suicides account for nearly a third of all fatalities related to railroad operations in the U.S. and has increased over 10% in the last 5 years. The purpose of the **Railroad Trespassing Suicide Prevention** Program is to implement an outreach campaign to reduce the number of rail-related suicides that involve or result from railroad trespassing. Applications are due at 5:00 p.m. EST/4:00 p.m. CST on August 10, 2020.

# FHWA Accepting FLAP Applications until August 3

The Federal Highway Administration (FHWA) is accepting applications until Monday, August 3, 2020 for the FLAP. Public highway, road, bridge, trail or transit systems that are located on, are adjacent to, or provide access to certain Federal lands are eligible. An estimated \$1M will be available for programming. Project applications must be sponsored and/or supported by the appropriate Federal Land Management Agency (FLMA) unit whose access would be enhanced by the proposed action. If selected, a 20% matching share is required.

#### Metra Expands North Central Service Line to Meet Increasing Demand

As Chicagoans return to work and stay-athome restrictions are lifted, Metra is expanding its service on the North Central service Line to meet the needs of its growing ridership. On Monday, June 29, service was expanded to include morning and evening express trains, marking the first time that express service has been available on the line.

Metra is adding a 6:38 a.m. inbound departure from Antioch. The train will make all stops between Antioch and Buffalo Grove and then express to Western Avenue, arriving at Chicago Union Station at 8:04 a.m. A 5:01 p.m. outbound departure is also being added to the schedule for the evening commute. This train will operate express to Buffalo Grove and arrive in Antioch at 6:29 p.m. The expanded schedule can be found <u>here</u>.

#### Grant Opportunity to Support Streets for Pandemic Response and Recovery

The National Association of City Transportation Officials (NACTO), with funding from Bloomberg Philanthropies, is offering grants of \$25,000 to ten member city transportation agencies that are partnering with community-based organizations to reimagine streets, implement ideas, and support ongoing community efforts that meet the needs of populations disproportionately harmed by COVID-19. Cities with populations of less than 500.000 that haven't received federal aid. as well as larger cities targeting interventions in neighborhoods that have historically and continue to be underinvested will be prioritized. Each NACTO member may only submit one application. The deadline for this application is 8:00pm ET on Friday, July 10, 2020. More information and an application are available here.

# Union Pacific and Metra Open Negotiations Over Control of Commuter Lines

Union Pacific is negotiating a new agreement with Metra to outline their ongoing and future relationship. Under the new agreement. Union Pacific seeks for Metra to assume direct responsibility to hire and supervise employees, and have control of the equipment needed to operate the Union Pacific (UP) North, Northwest and West lines. Union Pacific would continue to maintain the track and manage train movement across its lines. This proposed new arrangement is similar to what commuters already experience on the Metra North Line, hosted by Canadian Pacific, or the Metra Southwest Line, hosted by Norfolk Southern. With the new agreement in place. Metra will have direct control over 10 of the 11 commuter lines in Chicago.
