I. Call to Order/Introductions

Ms. Beckner called the meeting to order at 10:31 a.m.

II. Approval of May 24, 2022 Meeting Minute

Mr. Buehler moved approval of the September 20, 2022 meeting minutes. Mr. Mangum seconded the motion, which was unanimously approved.

III. CMAP Safety Resource Group Update

Ms. Barrett, provided an update on the progress of the Chicago Metropolitan Agency for Planning's (CMAP) Safety Resource Group. Her update included an

overview of regional traffic safety efforts, speed management strategies, bicycle and pedestrian safety, safe streets and roads for all and, safe and complete streets program.

Mr. Lysicatos asked what municipalities can do with a safety action plan since many county roads have higher speed limits than municipality-owned ones.

Ms. Barret said that the criteria for the Safe Streets for All Grant evaluation criteria focus on cross-jurisdictional partnerships. Counties and regional councils will have a big role in helping identify areas of risk and work with the municipalities to address safety and pull together implementation applications.

Mr. Green reported that Hoffman Estates received a grant from IDOT to create a multi modal transport pan for their community.
