I. Call to Order/Introductions

Ms. Beckner called the meeting to order at 10:30 a.m.

II. Approval of November 22, 2022 Meeting Minutes

Mr. Mangum moved approval of the November 22, 2022 meeting minutes. Mr. Baxa seconded the motion, which was unanimously approved.

III. Americans with Disabilities Act (ADA) Resources

Chicago Metropolitan Agency for Planning (CMAP) Senior Planner Jake Seid presented information on their work to support communities in complying with Title II requirements and other resources available to guide ADA improvements.

Ms. Beckner asked which departments in local government should be involved in making sure the ADA plans are successful. Mr. Seid responded that elected officials, engineers, public work departments and mangers should all be involved.

Mr. Porter asked if there was a list of municipalities with where they currently stand in compliance with ADA. Mr. Seid said that CMAP does not have that level of detail and only knows if a community currently has or does not have a plan.

Mr. Baxa asked if CMAP was considering hosting ADA events at CMAP offices rather than the far south suburbs. Mr. Seid answered that there trying to reach other geographical areas of the region they don't go t usually and all of these meetings are planned to be hybrid so you could join from anywhere.

IV. Local Project Updates

Mr. Harper shared that the Village of Bartlett's board passed a resolution to adopt the Bartlett-Streamwood Bicycle and Pedestrian Plan. The village has also began incorporating some of its bike paths in its capital budget projects.

Ald. Sanoica updated the committee that Rolling Meadows is moving forward with a sustainability plan that includes a lot of initiatives for bicyclists and pedestrians.

Mr. Baxa announced that Northbrook will have its Phase II starting for the Shermer Rd Multi-Use Path. Preliminary concept plans for Walters Ave, is also being completed.

Ms. Gabiga shared that Elk Grove is in the process of adopting an ADA transition plan and will be releasing it for public comment now.

V. Other Business

Staff announced that they are working to identify a potential route / segment that would involve multiple member communities that could apply for a larger funding program. Staff received initial criteria from committee members and some prospective project ideas that will be shared with the committee at the next meeting.
