The spring introduction of the Metropolitan Mobility Authority Act (HB5323) in Springfield initiated a conversation about the vision of regional public transit. In response, the Northwest Municipal Conference (NWMC) assisted members in developing the guiding principles for future transit legislation. Officially adopted by the NWMC over the summer, the document is now available for distribution.

Senate Transportation Committee Chair Ram Villivalam has also been hosting subject matter hearings on public transit in the region throughout the summer. So far, hearings have been held in Chicago, the South Suburbs of Cook County, DuPage, Will and Kendall Counties, and Kane and McHenry Counties. Upcoming hearings are scheduled in the Northwest Suburbs of Cook County, Lake County, and a final hearing in Springfield.

Staff will provide a brief overview of the origin of the transit fiscal cliff, the status of the hearings, and the NWMC Regional Transit Legislation Guiding Principles.

I. Call to Order/Introductions

Trustee Porter called the meeting to order at 10:32 a.m.

II. Approval of May 14, 2024 Meeting Minutes

Mr. Buehler moved approval of the May 14, 2024 meeting minutes. Mr. Mangum seconded the motion, which was unanimously approved.

III. NWMC Bicycle-Pedestrian Committee Summer Field Trip

Mr. Czarnota shared the location and details for this year's Bike Field Trip, which will be held in the Village of Glenview at The Glen. He noted that attendees will meet at the Glenview Park District Park Center building to begin the ride and see completed improvement projects at Shermer Road and Chestnut Ave. Staff shared that a pedestrian route will also be offered.

Ms. FioRito asked what the total time, inclusive of presentation, would be. Mr. Czarnota indicated that the 2023 event was scheduled from 10:30 to 1:30, but ended by 1:00. Mr. Larson shared that last year the event was held in June, and the later start time was potentially cooler.

Mr. Mangum preferred that the event syncs up with lunch, with Ms. FioRito suggesting a 9:30 a.m. to 12:30 p.m. event. Trustee Porter recommended that staff schedule the event for the 9:30 start time.

Trustee Porter asked whether local bike shops would be present to assist attendees. Mr. Czarnota indicated the shop at the 2023 event was local and involved with the creation of the bike paths, hence their involvement. Ms. Webb recommended the Glenview Cycle shop as a partner for the 2024 event. Mr. Larson said that NWMC staff would reach out to the shop to determine their availability.

IV. 2024-2025 Meeting Dates

Staff presented the proposed meeting dates for FY 2024-2025. Mr. Mangum suggested that it would be beneficial to have a future June meeting on the schedule due to the number of active transportation-related municipal events. Mr. Czarnota said that NWMC staff can add a June meeting on June 10, 2025 at 10:30 a.m. to the schedule and that there would be no staffing concerns. Trustee Porter voiced his support due to its ability to help plan future events.

Mr. Buehler moved approval of the 2024-2024 Meeting Dates. Mr. Nielsen seconded the motion, which was unanimously approved.

V. Other Business

Mr. Czarnota shared that the Active Transportation Alliance is looking to identify Active Transportation Infrastructure Investment Program (ATIIP) eligible projects within Quigley's (IL-5) district, and encouraged members to contact NWMC staff with recommendations.

Ms. FioRito shared that Evanston is developing an income-qualified bike voucher program pilot, including traffic safety education as part of school-based educational programming. She asked that any communities with experience building educational programs contact her at sfiorito@cityofevanston.org.

Mr. Green shared that Crank Revolution is hosting a free bike tour of Hoffman Estates, with both a 4.5 and 25 mile route option, starting and ending at Crank Revolution. The 25 mile route can be found at https://ridewithgps.com/routes/47018806 and the 4.5mi Route at https://ridewithgps.com/routes/47018970.

Mr. Mangum shared that Evanston has organized group rides, including a family ride and adult ride held in May. The next ride is Saturday, June 29. Mr. Mangum added that the Village of Skokie is hosting an open house for its Church Street bike lanes on Thursday, June 27, 5-7 PM at the Weber Leisure Center. Mr. Czarnota and NWMC staff thanked Chairman Porter and the Committee's involvement for their work this year. He added that staff will see everyone July 9 at the Field Trip.

Northwest Municipal Conference Regional Transit Legislation Guiding Principles

The \$730 million "fiscal cliff" presents an opportunity to discuss and address how to improve regional transit services. The Northwest Municipal Conference believes that any legislation should focus specifically on how to leverage assets to better serve the evolving transit needs of the Chicago region.

Key Principles

Transit should accommodate the evolving needs of system users

- Better integration of services
- Updated schedules and networks that reflect modern daily needs
- Greater access to key generators (employment centers, educational/medical/cultural resources, etc.)

Governance should represent the region

- Critical votes representing suburban Cook County and the collar counties on the governing board(s) must be preserved and strengthened
- Need for municipal elected official input in governing board appointments
- Governing board decision making should align with local and regional needs

Transit requires sustainable funding

- Should reflect an investment in the region's ongoing economic success
- Revenue sources should not place an undue financial burden on riders or taxpayers
- Any legacy financial obligations or debt (e.g. CTA pension liabilities) should not be shifted onto other constituent groups

Reconnecting Communities Pilot Grant Program

Reconnecting Communities Pilot Program FY24 NOFO is now live. Applications are due at 11:59 Eastern on September 30, 2024.

Reconnecting Communities Pilot (RCP) Program Overview

The Office of the Secretary of Transportation (OST) has released an FY24 Notice of Funding Opportunity (NOFO) for the Reconnecting Communities Pilot (RCP) program. This is a continuation of two previous rounds of RCP Funding in FY22 and FY23. The RCP Program focuses on improving access to daily needs such as jobs, education, healthcare, food, nature, and recreation, and foster equitable development and restoration, and provide technical assistance to further these goals.

Funding for this fiscal year is a combined allocation of FY 2024, 2025, and 2026. **Up to \$607 million is available for planning, capital construction, and technical assistance.** The funding will be implemented as appropriate and consistent with the priorities in Executive Order 14052.

The Department will prioritize grant funding applications that demonstrate the following characteristics:

- Equity and Justice40 (i.e., will benefit economically disadvantaged communities)
- Access
- Facility Suitability
- Community Engagement, and Community-based Stewardship, Management, and Partnerships
- Equitable Development
- Climate Change Mitigation and/or Adaptation and Resilience
- Workforce Development and Economic Opportunity
- Planning Integration

Potential applicants who are interested in pursuing a reconnecting type project but are not prepared to submit funding requests within 90 days can submit a request for technical assistance through the <u>Reconnecting Communities Institute</u>. Many reconnecting projects are also eligible for funding under formula programs or eligible discretionary grant programs.
