I. Call to Order/ Introductions

Trustee Buehler called the meeting to order at 10:32 a.m. and asked those present for introductions.

II. Approval of January 16, 2018 Meeting Minutes.

On a motion by Ms. Marrin, seconded by Mr. Spila, the committee voted to approve the meeting minutes.

III. Surface Transportation Program Project Selection Committee Update

Mr. Walczak provided background information regarding changes to the region's STP allocation. He described the memorandum of understanding between the Council of Mayors and the City of Chicago. He discussed possible active program management policies and criteria connected to the regional plan which would be included in council methodologies.

He described the project selection committee schedule and timeline for council methodology updates. Ms. Marrin asked how the new funding allocation was

determined. Mr. Walczak described the five criteria involved in that process. Mr. Peebles asked how single occupancy vehicle numbers were judged. Mr. Walczak replied that it was the number of SOV commuters. Mr. Spila asked who was compiling the data. Mr. Walczak replied that IDOT files from 2016 were used. Mr. Spila asked if the data would be updated before the 2020 call for projects and Mr. Walczak replied that it would and CMAP was currently working on a regional pavement management system.

IV. NWMC Multimodal Plan Update

Mr. Walczak reported that there were no updates on the conference bike plan since January's meeting.

V. Upcoming Events

Mr. Pigeon discussed the upcoming Illinois Bike Summit, RTA Planning Workshop and Complete Streets Coalition quarterly meeting. Ms. Beckner asked if sessions at the Bike Summit qualified for CM credits. Mr. Pigeon replied in the affirmative.

VI. Local Project Updates

Ms. Marrin discussed a project to be let in April 2018 and a project slated for 2020 to expand the bike path at Nippersink Blvd. Mr. Knapp announced the Phase I open house for the Rowling Road bike path. Mr. Walczak added that the Roselle Road bike path was on the April construction letting.

VII. Other Business

Mr. Walczak discussed the 2018 call for Invest In Cook grants, noting that applications are due March 16. He also noted that later in the week a kick-off meeting for Phase I planning along the Des Plaines River trail in the West Central Municipal Conference area would be held.

Chair Buehler announced that the next meeting was scheduled for March 20, 2018 at the NWMC offices.
