#### I. Call to Order

Ms. Webb called the meeting to order at 10:07 a.m.

#### II. Approval of Meeting Minutes – April 17, 2025

Mr. Rietveld moved approval of the April 17, 2025 meeting minutes. Mr. Tomich seconded the motion, which was unanimously approved.

#### III. Agency Reports

#### a. Chicago Metropolitan Agency for Planning

Ms. Stolpe said that CMAP has begun several community engagement initiatives, including the Climate Action Plan and the Regional Transportation Plan, both of which have public surveys on the CMAP website. She requested that communities continue to update the Northeastern Illinois Development Database.

Ms. Stolpe shared that the next meeting of CMAP's ADA Regional Coordinators Group will be August 12<sup>th</sup>. Ms. Stolpe also said that CMAP has released new local housing profiles for individual communities. She also shared that CMAP has been awarded additional state funding to address planning objectives, and that the CMAP MPO Policy Committee has approved the STP-Shared, TAP-L, and CMAQ funding award applicants.

#### b. IDOT Local Roads Update

No report attached. Mr. Househ was available to answer any questions.

#### c. IDOT Highways Report

Report attached. Mr. Larson noted that some labeling and designations in the report were incorrect and that he would notify IDOT Highways of the requested changes.

#### d. Illinois Tollway

Ms. Passi shared that the Illinois Tollway's Bridging the Future \$2 billion capital plan is beginning next year. She added that the IPASS On Demand Team is available to provide in-person customer service at local events, including signing up customers for the IPASS Assist Program, and said that communities can check the event calendar for existing engagement opportunities or to sign up the On Demand Team for local events.

#### e. Metra

No report attached.

#### f. Pace

Ms. Rybarczyk announced that Pace has launched the regional day pass pilot, which provides unlimited daily rides on CTA, Metra, and Pace. She added that Pace will be holding several upcoming public hearings on changes to the ADA Paratransit program.

Ms. Rybarczyk notified Mr. Tomich that she is following up on his request for pylon completion dates for the Pace Pulse Dempster Line project and will provide him with that information directly.

Ms. Rybarczyk said that as of May, Pace has provided more than 2 million rides, a 4.5% year-over-year increase.

#### g. RTA

Report attached.

#### h. Cook County Department of Transportation and Highways

Mr. Ruehle said that CCDOTH will provide quarterly reports ahead of the next meeting, and there will be a new CCDOTH representative at future meetings.

## IV. North Shore Council of Mayors Surface Transportation Program (STP) Changes a. Local Surface Transportation Program (STP-L) FFY2025-2029 Update

due to final availability of costs.

Mr. Larson provided a brief overview of the current program, noting changes since the previous meeting including removal of duplicate projects following project mergers and a reduction in the programmed amount for Beckwith Road from \$2,916,000 to \$1,755,525

Mr. Larson added that he has initiated conversations with communities whose funds are unobligated carryover from prior fiscal years. He noted that several are moving forward and will be obligated by end of the current fiscal year while others are still awaiting local action and will be carried over impacting the FY2026 allocations.

Mr. Beladi moved for adoption of the FFY2025-2029 Program as presented. Mr. Rietveld seconded the motion, which was unanimously approved.

## b. North Shore Council of Mayors Surface Transportation Program (STP) Cost Increase Requests

Mr. Larson shared requested cost increases from projects in the FFY 2025-2029 Program, including Morton Grove's Central Avenue and Glenview's Glenview Road and Harlem/Lehigh Avenue. Mr. Larson noted that the increases are to be scheduled as conditional due to the multiple factors of needing to approve funds within a short period prior to contract end dates, fiscal constraint, and inability to program the funds at the current time.

Mr. Rietveld moved for conditional approval of the requested cost increases for FFY2026, pending availability of STP-L and/or Planned Use of Redistribution adoption. Mr. Welch seconded the motion, which was unanimously approved.

#### V. Methodology Revision Pavement Condition Analysis Discussion

Mr. Larson led a discussion regarding potential revisions to the pavement condition criteria in the methodology. Ms. Sarna asked Mr. Househ about verification of local pavement condition scores and what standard is utilized. Mr. Househ responded that the information comes from the Bureau of Pavement and would use core samples. Mr. Rietveld asked whether pavement condition data affected project ranking. Mr. Tomich replied that a difference in project pavement scores caused one project to not receive STP funding.

Ms. Stolpe said Cook County pavement data would be getting updated by IDOT within the next two years, but the major concern from CMAP's perspective is consistency of data sources as CMAP no longer has an in-house pavement data specialist to directly verify the data. Mr. Tomich asked whether a similar index among the communities to the IDOT valuation would address that concern. Ms. Stolpe replied that CMAP could support such an effort, but it would take time to confirm the similarity.

Mr. Beladi suggested that the North Shore proceed with the status quo and make revisions as needed in the future. Ms. Webb suggested that the North Shore utilize a similar process as the Northwest Council of Mayors where communities can request an individualized appeal. Ms. Sarna replied that the benefit to having a system in place for updated scores

for the current call for projects is that current scores are heavily outdated, but that North Shore could trial an appeals process with the Technical Committee. Ms. Webb suggested adopting a motion with language that would allow usage of local data on an appealable basis.

Mr. Beladi moved to approve the status quo pavement condition data process with an appeal available at the Technical Committee meeting to use local data on a majority vote. Mr. Tomich seconded the motion, which was unanimously approved.

#### VI. Report by Methodology Revision Working Group

Mr. Larson shared the final draft revision of the North Shore Council of Mayors STP Program Selection Methodology for adoption. Mr. Larson thanked the members of the methodology working group for their time and work on the methodology.

Mr. Tomich moved to approve the proposed methodology, including passed motion by Northbrook to allow an appeal at the Technical Committee meeting to use local data on a majority vote. Mr. Welch seconded the motion, which was unanimously approved.

#### VII. Other Business

Ms. Webb asked Mr. Larson for the STP-L Call for Projects dates. Mr. Larson replied that the application period is a 60-day window that will open in October and close in December. Mr. Larson said NWMC would be hosting an STP-L workshop in early fall and encouraged communities to attend.

Mr. Larson thanked Glencoe, Kenilworth, and Lincolnwood, whose mayors and presidents had applied to represent the North Shore Council of Mayors. He said that there will be an election among the North Shore Council of Mayors for the two openings, and the results will be adopted by resolution in August.

Mr. Larson said that the NWMC is currently reviewing e-bike and e-scooter ordinances and is interviewing municipal staff and elected officials to host a summit on the topic in the fall. He asked communities who are considering or which have adopted one to contact either himself or Mr. Czarnota.

#### VIII. Next Meeting

Ms. Webb said the next meeting of the North Shore Council of Mayors Technical Committee is Thursday, October 16, 2025, at 8:30 a.m. at Glenview Village Hall, 2500 E Lake Street, with a virtual non-voting option available.

Mr. Milanesio moved to adjourn the meeting at 11:11 a.m. Mr. Beladi seconded the motion, which was unanimously approved.

#### **CMAP products and data**

#### **Explore the CMAP data hub**

CMAP's <u>Data Hub</u> provides vetted and trustworthy information about northeastern Illinois so local governments, community organizations, academic researchers, and businesses can learn and make informed decisions about their communities. The Data Hub allows you to search or browse by categories and tags. You can find tables or shapefiles for transit routes and stops, land use inventory, greenhouse gas emissions, economically disconnected and disinvested areas, bikeway inventory system, and more!

#### From our partners

#### 2024 IDOT National Highway System (NHS) pavement and bridge data

IDOT collects condition data on Interstate pavements annually and on non-Interstate pavements on a two-year cycle. Bridges receive a routine visual inspection at least every 2-4 years, depending on the condition. The results of the most recent NHS pavement condition assessments and bridge inspections, along with performance measures and targets, may be accessed on IDOT's "Performance" webpage.

#### 2024 IDOT crash data

On August 11, 2025, IDOT released <u>Circular Letter 2025-11</u> announcing the availability of the 2024 crash data. This data set provides important crash information required for the identification of areas of improvement, work on safety studies, and the analysis on the location and number of crashes. The data can be accessed through <u>IDOT's Safety Portal</u>.

#### **Vulnerable Road User Safety Assessment (VRUSA)**

The IDOT <u>Vulnerable Road User Safety Assessment (VRUSA)</u> is available for download and use. The VRUSA contains IDOT's efforts to help stakeholders identify programs and projects to address vulnerable road user safety through stakeholders' engagement and data analysis. It also outlines safety strategies based on the safe system approach with a profound consideration for equity principles. It is IDOT's intention for this document to be an important tool for stakeholders to continue to address the needs of VRU's in their communities.

To assist in the use of the VRUSA for the planning of future projects that address the safety of VRUs, a <u>VRUSA Dashboard</u> has been created that allows the user to view the results of the VRUSA data analysis in a way that can be filtered to specific areas of the state.

#### **Funding opportunities**

#### **IDOT Safe Routes to School Cycle 2025**

On July 11, 2025, the Illinois Department of Transportation released <u>Circular Letter 2025-10</u> detailing the notice of funding opportunity for the 2025 <u>Illinois Safe Routes to School (SRTS)</u> program. IDOT will be accepting applications for the SRTS grant beginning **August 1, 2025, through October 13, 2025**. The SRTS supports projects and programs that enable and encourage walking, rolling, and bicycling to and from school. SRTS will be 100% funded and require no local match.

To assist in your preparation of the upcoming cycle, the IDOT has partnered with Active Transportation Alliance to offer an informational webinar series. Each webinar date has a unique agenda. Recordings and additional information are available on the SRTS website.

#### IEPA Green Infrastructure Grant Opportunities (GIGO)

The Green Infrastructure Grant Opportunities (GIGO) program utilizes funds distributed by the State of Illinois generated under the Build Illinois Bond Fund. Illinois EPA's Notice of Funding Opportunity includes \$5,000,000 in funding for projects that will improve water quality in Illinois. GIGO has set a maximum total grant award of \$2,500,000 with a minimum grant award of \$75,000. The GIGO program funds projects to construct green infrastructure best management practices (BMPs) that prevent, eliminate, or reduce stormwater runoff into Illinois' rivers, streams, and lakes.

Eligible projects will construct BMPs to decrease stormwater runoff prior to release into rivers, streams, and lakes, and include:

- 1. Reconnection of a stream with its floodplain (e.g., two-stage ditch, daylighting);
- Treatment and flow control of stormwater runoff at sites directly upstream or downstream of an impervious area that currently impacts river, stream, or lake water quality through stormwater runoff discharge; and/or
- 3. Treatment and flow control of water generated from impervious surfaces associated with urban development (such as roads and buildings).

Applications are being accepted now through **November 5, 2025**. Full application details and more information are included in the Notice of Funding Opportunity through AmpliFund.

## Transit agencies update fiscal cliff projections and break down potential service cuts

The RTA has worked with CTA, Metra, and Pace to update the preliminary funding shortfall for 2026 and projections for both 2027 and 2028 as part of its annual budget process. A budget task force made up of finance and planning staff from RTA, CTA, Metra, and Pace now projects an estimated preliminary budget gap of approximately \$200 million in 2026 that will increase to almost \$790 million in 2027 and almost \$890 million in 2028 without new state funding. RTA Board Chair Kirk Dillard released a statement on the new projections, and meeting materials and video of the Service Board presentations are available online.

Higher-than-expected RTA sales tax revenue starting in 2025 and short-term cost saving actions have reduced the 2026 shortfall as the transit agencies work to delay rider impacts, but fare increases, service cuts and staff layoffs are still expected in 2026 absent new revenue, and these rolling cuts will worsen in future years.

Even with these short-term cost saving actions, 2026 will be a difficult year without new funding. A systemwide fare increase is planned for February and CTA will have to plan for service cuts and layoffs in the second half of 2026. Cuts to the ADA Paratransit service area, as well as the rideshare (RAP) and taxi access programs (TAP) are also expected. Since it is a regional system, when one operator is forced to cut service, all four agencies will need to coordinate on the impacts.

Service Board reserves, including any remaining federal relief funds will be exhausted by 2027, with a projected preliminary funding gap of approximately \$790 million that will grow in 2028. Without state action, the region will face rolling service cuts and layoffs reducing transit by up to 40%.

#### Transit budget hearings scheduled throughout the region

Each year, the RTA reviews, adopts, and monitors the annual operating budgets of CTA, Metra, and Pace. The process begins in earnest in the fall, when the Service Boards present their initial budget proposals to their boards and the public. The RTA will also schedule a series of presentations throughout the region to present the proposed 2026 regional operating budget and five-year capital program. RTA staff will be made available at public open houses following each of the presentations for members of the public to provide feedback.

#### **ADA Paratransit Action Plan takes effect October 1**

Pace Suburban Bus, the region's ADA paratransit operator, launched the Rideshare Access Program (RAP) in 2024 as a pilot program to complement traditional ADA paratransit service, along with the Taxi Access Program (TAP). RAP and TAP have experienced rapid growth in recent years, leading to a \$25.5 million deficit in 2024 that's projected to grow to \$35-\$65 million in 2025. The RTA is obligated by state law to adopt and maintain balanced budgets, so the agency created an ADA Paratransit Action Plan designed to ensure the future health and viability of accessible transportation service. Actions taking effect on October 1, 2025, include:

- Establishing a 30-ride per month cap for both RAP and TAP. This does
  not affect traditional ADA paratransit service, which remains a
  transportation option for certified riders. Data shows 5% of eligible riders
  use RAP and TAP more than 30 times per month currently; the average
  number of trips taken using RAP or TAP is 12 rides per month.
- Restoring the current \$2 RAP and TAP fares to match traditional ADA at \$3.25.
- Offering free rides on all system-wide fixed route service to ADAcertified riders, which is currently offered only on Pace fixed routes.

These immediate actions alone cannot solve the budget shortfall. **Future actions will include:** 

- A **fare increase** for traditional ADA paratransit along with fixed route modes as part of the 2026 budget.
- **Improved ridership and cost projection** during the budget development process.
- Potentially further adjustments to RAP and TAP program parameters.
- Better aligning the county Rideshare Access services with ADA Rideshare Access to standardize fares across programs and ensure the best use of limited resources.
- Potentially ending RAP and TAP in April 2026 without additional state funding.

#### RTA, Service Boards prepare for fall legislative session

Our region's transit system is headed toward a <u>fiscal cliff</u>. Without new funding, CTA, Metra, and Pace face a budget gap in 2026 that will grow substantially in future years. Riders everywhere could experience <u>significant service reductions</u>, the pause or cancelation of new or expanded services, fare increases, employee layoffs, and other consequences without action from Springfield.

The RTA, lawmakers, and advocates have made it clear that any new funding for transit should be paired with reforms to empower the regional entity to handle the most important systemwide issues: <u>fares</u>, <u>service quality</u>, and <u>capital investment</u>. The RTA published <u>Transforming Transit</u> at the beginning of this year – the agency's vision for a world-class transit system paired with \$1.5 billion in annual operations funding. #### Local travel guides now available on RTA website

The RTA launched its <u>Travel Assistance Digital Library</u> in Fall 2024 to offer riders a one-stop location for information on all of the programs offered or certified by the RTA, including affordable fare programs, ADA paratransit, and other rider services. New to the digital library this month are local travel guides for each of the six counties in the RTA region, with Cook County being divided into four subregions. The travel guides include service, eligibility, reservation, and other relevant information for a variety of local transportation options, such as municipal bus programs, dial-a-ride, and other special services.



# Transit agencies update fiscal cliff projection for 2026 and 2027 and break down potential service cuts

The Regional Transportation Authority (RTA) has worked with CTA, Metra, and Pace to update the preliminary funding shortfall projections for 2026, 2027 and 2028 as part of its annual budget process. A budget task force made up of finance and planning staff from RTA, CTA, Metra, and Pace now projects a preliminary budget gap of approximately \$200 million in 2026 that will increase to almost \$790 million in 2027 and almost \$890 million in 2028 without new state funding.

Note: All the figures are based on preliminary budget submissions from CTA, Metra, and Pace. These projections define the scope of the challenge, but may be updated as the budget process advances. For the latest updates visit the Regional Transit Fiscal Cliff Hub.

#### How the cliff changed for 2026

Higher-than-expected RTA sales tax revenue starting in 2025 and short-term cost savings have reduced the 2026 shortfall as the transit agencies work to delay impacts on riders. Fare increases, service cuts, and staff layoffs are still expected in 2026 absent new revenue, and these rolling cuts will worsen in future years.

Following is a breakdown of approximately \$570 million in new revenue and efficiencies in the preliminary regional budget that resulted in the cliff dropping from an estimated \$771 million to approximately \$200 million for 2026:

- \$232 million in higher-than-expected returns from the RTA sales tax and state matching funds from the Public Transportation Fund (PTF) anticipated in 2026
- \$196 million in CTA, Metra, and Pace reserve funding available because of 2025 expenses consistently coming in under budget, higher 2025 sales tax and PTF revenues
- \$77 million from reallocating \$17 million in Innovation, Coordination, and Enhancement (ICE) project funding from capital to operating budgets, and excluding previously planned \$60 million transfer of Metra farebox revenue to capital
- **\$39 million** in net lower expenses including \$63 million in efficiencies that are partly offset by higher costs in some categories like healthcare. Efficiencies include staffing freezes, coordinated fuel and power purchases, delaying planned service expansions, and other actions.
- **\$26 million** in new net system-generated revenues from a planned 10% fare increase in February, partly offset by lower interest income from declining reserves

#### Preliminary estimates of fiscal cliffs for 2026-2028 (in millions)








#### Potential 2026 cuts and fare increases

Even with these actions, 2026 will be a difficult year without new funding. A systemwide fare increase is planned for February. CTA could face a 25% service cut later in the year, which could mean up to 39 bus routes eliminated, one entire L line closed, and some mid-day, late-night, early, or overnight service eliminated. By early 2027, CTA estimates it may be forced to cut up to 1,800 union and non-union positions, with layoffs beginning in the summer of 2026. Cuts to the ADA Paratransit service area and the rideshare (RAP) and taxi access programs (TAP) are also expected.



#### Potential 2027 cuts and fare increases

Service Board reserves, including remaining federal relief funds will be exhausted by 2027, with a projected funding gap of approximately \$790 million that will grow in 2028.

#### **RTA Transforming Transit reform proposal**

RTA has advocated for new funding to be paired with reforms that would increase efficiency and accountability for riders and taxpayers. In January, we released <a href="Transforming Transit vision">Transit vision</a> and <a href="Legislative proposal">Legislative proposal</a> to deliver faster, more frequent, safer, reliable transit service. The proposal empowers the regional entity with broad authority to monitor and improve systemwide service quality, fare policy, and capital planning, allowing the Service Boards to focus on delivering high-quality service.

#### What's next?

The RTA will continue to monitor revenues and expenses and update projections for the Governor and General Assembly quarterly, as outlined in the RTA Act. RTA leadership and staff are eager to meet with you to answer any questions and discuss how we can continue to work together on a funding and reform solution.

#### Invest in Cook 2025 Program

Seven grantees in the Northwest Municipal Conference were awarded Invest in Cook funding for the 2025 program, including one roadway, three pedestrian, two bike, and one transit service projects. #### **Rail Infill Station Study Status**

CCDoTH is teaming up with CDOT, CTA, and Metra to holistically study where future rail stations may be warranted along rail transit lines in Cook County. The study is compiling a list of candidate sites, which will be assessed, screened, and prioritized using a combination of quantitative and qualitative measures. As part of the screening effort, a public survey will be launched this fall, which will solicit ideas for where stations should be considered. The study will ultimately produce a recommended set of stations for further development by the transit agencies.

#### **Cook County Safety Action Plan**

The CMAP Policy Committee accepted the Cook County Safety Action Plan on May 30, 205, and the report is available here: <a href="https://engage.cmap.illinois.gov/cook">https://engage.cmap.illinois.gov/cook</a>. The plan describes crash trends, issues, and the High Injury Network for all roads in Cook County from 2018 through 2022. The report provides recommendations for policy, program, and infrastructure improvements to reduce fatalities and serious injuries from traffic crashes. The plan makes all governmental entities in Cook County eligible for demonstration and implementation grants under the USDOT Safe Streets for All program.
