The Village of Wilmette is formally requesting additional funding from the Northshore Council of Mayors for the Old Glenview Road Resurfacing Project. This project was included in the March 8, 2024, IDOT Letting, and the lowest responsible bid submitted was \$1,244,877. This bid exceeds our initial estimate prepared in Phase I of \$1,126,507. The Construction Engineering was significantly below the Phase I estimate and after accounting for the Construction Engineering savings, the project is currently facing a funding shortfall of \$54,975.

To account for this shortfall, the Village of Wilmette is formally requesting an additional \$43,980, which represents 80% of the shortfall, in line with typical funding practices.

In 2008, the Village of Winnetka began the Phase I planning engineering for the reconstruction of Willow Road from Forest Way Drive to Provident Avenue. This project received design approval in 2013. At the time, the project had an opinion of probable construction cost of \$5,086,800.

Shortly after design approval, the Village embarked on a stormwater study of their Westside to solve severe flooding issues that included this section of Willow Road causing a delay in the project. The Village recently completed their stormwater study and was able to move forward with Phase II design engineering of the Willow Road project.

The Village's consultant, Strand Associates, Inc., prepared a revised opinion of probable construction cost for construction of Willow Road in 2026. The revised OPCC was \$10 mil. The NWCOM currently has allocated \$2,469,214 of STU funding for construction. The Village is requesting additional STU funding from NWCOM for the construction of the project to assist in the construction funding of the project.

On October 12, 2022 the CMAP Board and MPO Policy Committee approved funding for the Shermer Road Improvements in FFY 2025. The funding was approved for the construction phase of the project with STP-Local committing \$2,002,400 based on an estimated project cost of \$2,503,000.

The submitted project cost at that time was based on a preliminary cost estimate provided by the consultant completing the Phase I engineering for the project. The project scope increased to include additional green infrastructure elements and traffic calming measures. The preliminary cost estimate did not include a comprehensive list of all pay items that were included in the final IDOT approved Phase I project development report (PDR). These items include asphalt pavement resurfacing, concrete pavement patching, and transition lighting for the proposed sidepath. Phase II engineering is currently in progress and is being funded through an Invest in Cook grant and local funding. This project is scheduled to be let in September of this year.

The current construction cost estimate that was provided in the final phase I PDR, the quarterly reports, and the current PPI is \$5,029,000. The Village is requesting 80% of the estimated construction cost or \$4,023,200, an increase in funding of \$2,020,800. The Village understands that this request is a substantial increase from the initial approved funding and would be receptive to any additional assistance that can be provided. The City of Evanston is submitting this letter to the Northshore Council of Mayors to request additional funding for the improvements of Green Bay Road from McCormick Boulevard to Isabella Street, and Central Street from Prairie Avenue to Broadway/Poplar Avenue. This project is planned for September 2024 letting and the construction to be completed in 2025.

The City previously received approval for Surface Transportation Program (STP) local funding for the Construction and Construction (Phase III) Engineering in 2019. The requested funding amounts were based estimates prepared during the Phase I. The approved STP funding amounts are as follows:

The City of Evanston is in the process of completing prefinal PS&E and has developed detailed cost estimates for both construction and construction engineering. The cost of materials & services has significantly increased after the pandemic and all the project costs have been significantly higher than the pre pandemic estimates. The revised costs for both construction and construction engineering are higher than the previous estimates because of historic inflation.

Based on the revised estimates, the City requests additional \$1,970,000 in STP funds from NWMC for increase in the construction cost. This funding is critically important for the City to successfully complete the project and per the approved scope. The City continues to work with North Shore Council of Mayors to submit projects of regional significance for funding consideration and strongly requests the NSCM to approve this additional funding request.

Mr. Bernahl called the meeting to order at 8:35 a.m.

Approval of Meeting Minutes – January 18, 2024

Mr. Tomich moved approval of the January 18, 2024 meeting minutes. Ms. Webb seconded the motion, which was unanimously approved.

III. Agency Reports

a. Chicago Metropolitan Agency for Planning

Mr. Haadsma shared that CMAP has two remaining ADA training sessions, one on PROWAG on May 1 and one on the Illinois Accessibility Code on May 2. CMAP also maintains these resources online for later review.

Mr. Haadsma also noted several upcoming grant funding deadlines. First, Active Transportation Infrastructure Investment Program is open for applications through June 17. Second, Safe Streets for All (SS4A) grants are open, with multiple deadlines including May 16 and August 29. And third, IDOT EV infrastructure charging stations grants are open through May 7.

b. IDOT Local Roads Update

Mr. Fierro presented the April 8 status update sheet, noting there were not significant changes at this time. Mr. Fierro indicated that if any local planning agency is using Rebuild Illinois funds, to submit project authorization requests to meet deadlines.

Mr. Nagar asked if a Rebuild Illinois request meant IDOT needed a resolution from the municipality. Mr. Fierro replied a resolution was not needed, the LPA just needs to authorize and submit a Form 0950 for the money regardless of construction completion. Mr. Fierro clarified that IDOT assumes the LPA is using the entire award. Mr. Nagar said they have an Rebuild Illinois project this year and are completing the job, and wanted to be sure they submitting 0950 this year. Mr. Fierro responded that yes, the simple 0950 form was all that was needed.

c. IDOT Highways Report

Report attached to agenda. A representative on behalf of IDOT Highways was not present.

Mr. Larson shared a brief report from the IDOT Highways representative. IDOT Highways is developing its multi-year program announcement. Additionally, construction has begun for the season, with two projects on the April letting. These include Forest Way Drive, from Willow Road to Dundee Road, and Dundee Road from I-94 to Forest Way Drive. Mr. Bielak asked for confirmation of the roadwork's status. Mr. Tomich indicated the road was unincorporated.

d. Illinois Tollway

Mr. Panther presented on behalf of Illinois Tollway. Mr. Panther shared that there is currently a phishing scheme appearing to be from the Illinois Tollway and recipients should disregard those messages as the Tollway does not send texts regarding customer account information. Mr. Panther encouraged recipients to contact their local police department and the IC3.gov internet crime department.

Mr. Panther also provided an update on the Tollway's sticker tag conversion. Mr. Panther shared that there is no need to transition to a sticker until the physical transponder expires. Each vehicle will need a sticker, however.

Mr. Panther shared that Tollway is beginning its Capital Program outreach and taking early feedback.

Mr. Tomich asked if the Tollway has more information on the phishing scheme. Mr. Panther responded that the Tollway has a link about the scheme on its main page.

e. Metra

Report attached to agenda. A representative on behalf of Metra was not present.

f. Pace

Mr. Andrews presented on behalf of Pace. Pace is seeing positive trends in ridership, up 15% year over year, and operations staffing levels improving, but still short of goal. To reach that, Pace covers CDL course training at Harper College, resulting in new hires going directly to Pace training after completing the program.

Mr. Andrews shared that Pulse Dempster still needs station construction at some locations which will begin soon. These locations are mostly on the eastern end of the line in Evanston, Skokie, and Morton Grove, and communication with the municipalities about construction will be forthcoming.

Mr. Andrews shared the launch of Pace's Rideshare Access Program, which allows ADA riders to use TNCs, expanding service availability by mirroring the paratransit system.

Mr. Andrews introduced some staffing changes. First, Rick Willman, engineer, is retiring, and to please include Mr. Andrews or Ms. Rybarczyk in any future communications directed to Mr. Williams. Second, Mr. Andrews introduced Ms. Rybarczyk, who will be the new representative for the North Shore Council of Mayors. Mr. Andrews is now Manager of Community Relations. Ms. Rybarczyk introduced herself, sharing that she now lives in Niles but used to represent Pace's South/Southwest region. Mr. Larson requested Jessica to share contact information. Planning intros to individual communities.

FioRito: Share more information about operator roles and where to find information on wage levels and qualifications. Website postings are light. Andrews: Operator-specific handout for wage and bonuses will be distributed to committee. FioRito requested additional information on the website for the general public.

g. RTA

Report attached to agenda. A representative on behalf of RTA was not present.

h. Cook County Department of Transportation and Highways No report was presented. A representative on behalf of Cook County Department of Transportation and Highways was not present.

IV. North Shore Council of Mayors Surface Transportation Program (STP) Changes

Mr. Larson shared the program. Strong likelihood of use of Redistribution in FFY2025.

Mr. Nagar mentioned Evanston cost was based on unit costs from engineer's estimate.

Mr. Tomich asked for clarification on Contingency cost increase items and how the amounts compare to the total amount requested. Asked whether the applicants knew about the different amounts. Mr. Larson indicated he had contacted the applicants about the methodology limits on cost increase. Mr. Bielak confirmed that formulaic limitation was explained. Mr. Larson shared that the formula scales in accordance with the Council's marks and how much a project has already programmed of the annual marks. Mr. Larson shared that while there is a ceiling to the overall amount a project can request that can be raised, but cost increases are subject to a strict limit.

Ms. Webb asked about the year switch on Glenview projects and whether the projects can go back to the original order. Glenview Road and Harlem/Lehigh switch with other project. Mr. Larson shared that FFY programmed dates were based on the letting dates provided in the most recent QSU. Ms. Webb shared that the consultant completed the letting date based on the funding dates in the TIP, but project is a village priority. Mr. Bielak shared that these were two projects that were programmed for later date, but were still proceeding apace. Mr. Bernahl shared that a CMAP representative said there could be funds available. Mr. Larson shared that he had been developing a hypothetical as to what the program would look like in coming years, with the Council able to make use of significant Redistribution in FFY2025, moving out year projects back to FFY2025 and hit targeted letting dates. Mr. Larson said he would provide the hypothetical to the Council.

Mr. Bernahl shared that Redistribution is why the funds were moved to out years because it would not affect critical request projects.

Mr. Larson added that while FFY2026, 2027, 2028, and 2029 could not promise usage of Redistribution, usage of Redistribution during FFY2025 was certain to bring projects moved to out years back on track to their planned completion date.

Mr. Manis stated it was important to fully obligate, and earlier letting dates in the FFY to be planned to ensure all members can access the funds. Shared that projects would be programmed as early in the FFY as possible.

Mr. Larson indicated that only two projects are programmed for FFY2025 but these projects would use a substantive proportion of the Council's marks, allowing multiple projects to move up. Mr. Nagar said that Green Bay Road, one of the two FFY2025 projects, is in good position to proceed.

Mr. Larson shared the Active and Contingency List proposed program changes, with Active List approved applications receiving a percentage reduced amount below requested, and the remaining balance of the request programmed in the Contingency List once funding is available.

Mr. Larson shared that no public comments were submitted for the proposed program.

Mr. Bielak moved approval of the recommended cost increases. *Mr.* Rietveld seconded the motion, which was unanimously approved.

Mr. Manis moved approval of the recommended FFY2024 North Shore Council of Mayors STP-L. Mr. Bielak seconded the motion, which was unanimously approved.

c. North Shore Council of Mayors Surface Transportation Program (STP) Recommended Program for FFY 2025-2029

Mr. Rietveld moved approval of the recommended FFY2025-2029 North Shore Council of Mayors STP-L. Mr. Manis seconded the motion, which was unanimously approved.

Mr. Rietveld asked about the hypothetical chart. Mr. Larson shared that it would be based on if Redistribution was available, and projects hit their proposed letting date, what the overall program would look like. Mr. Rietveld asked about the composition of Redistribution and how it was forecast. Mr. Larson responded that the Redistribution balance is based on unused funds returned at the regional level and that information comes from CMAP, shared with each council's Planning Liaisons. Only Lake County and North Central Council of Mayors have utilized Redistribution recently since Active Program Management was instituted. Mr. Larson added that CMAP wants each council to fully obligate their marks due to concern that the federal government may plan to rebalance regional funding appropriations.

It was asked whether any other Council of Mayors would compete for the FFY2025 Redistribution funds that North Shore Council of Mayors could theoretically make use of. Mr. Larson responded that current use of Redistribution is limited, and how the North Shore Council of Mayors is programmed with two major projects could quickly use up those funds. Mr. Tomich added that getting the current projects to obligate earlier in August would be good. Mr. Czarnota shared that August is probably the earliest, due to multiple property owners and right of way concerns. Mr. Tomich expressed concern that would leave one month to obligate and make use of Redistributive. Mr. Larson acknowledged that concern, but shared that because that is during FFY2025, the Council could reprogram the entire North Shore active program to ensure the Council hits obligation to address the gap.

Mr. Bernahl requested that at the next Technical Committee meeting all projects touch base to ensure they are on track. Mr. Tomich wondered about hosting a between-meetings session instead as by July it could leave projects in a financial bind. Mr. Czarnota suggested having a meeting in June to see which projects hit the June letting date. Mr. Tomich responded that project managers would know in May whether they would be lined up in June, so a Memorial Day time meeting could be useful. Mr. Rietveld asked to confirm whether the discussion was about FFY2025? Mr. Bernahl confirmed yes. Mr. Rietveld said there's currently not a lot of breathing room with the August 2025 letting. Mr. Bernahl agreed and said that a check-in would be helpful. Mr. Tomich concurred, that all the projects were reliant on each other. Mr. Larson said that yes, the later letting dates in future FFYs could create bottlenecks, but that other projects could move up. Mr. Larson suggested that project managers could provide confidence levels of completion, and would organize a supplemental meeting to discuss a check-in.
