I. Call to Order

President Darch called the meeting to order at 8:30 a.m., and asked attendees to introduce themselves.

II. Approval of October 28, 2022 Meeting Minutes

Mr. Sfondilis moved approval of the October 28, 2022 meeting minutes. Mr. Bragg seconded the motion, which was unanimously approved.

III. Agency Reports

a. CMAP Report

Ms. Dobbs announced that applications for CMAQ, TAP and the STP Shared Fund are now open.

b. IDOT Highways Report

Written report provided.

Mr. Ottesen asked if there was a better way to coordinate with IDOT to determine responsibility to repair/maintain state routes and to better leverage funding. Mr. Househ recommended contacting John Baczek to coordinate.

c. IDOT Local Roads Update

Mr. Househ reviewed the status sheet handout and noted changes since the last meeting. He also announced projects that had received design approval. Mr. Househ concluded by informing the committee that when submitting agreements, the process should take 6-8 weeks if the documents are 95 percent correct, and delays in processing times are usually due to not making complete corrections. He said agreements typically take two months to be processed, and he recommended taking advantage of the section 1440 agreement, which allows for Phase I and II to be processed at the same time.

Ms. Johnson mentioned that Phase I and II are less of priority for IDOT than CON. However, she said Phase I and II are very important for municipalities because of active program management requirements.. She noted that the North Shore Council was running into similar problems and asked if a meeting between the regional councils of mayors, CMAP and others could be arranged. Mr. Househ agreed and said he would follow up with Ms. Johnson.

d. Illinois Tollway

Written report provided.

e. **Cook County Department of Transportation and Highways** Ms. Diaz announced that the 2023 Invest in Cook application is now open.

f. Metra

Ms. Dote reported that Metra secured a record \$240.1 million in grants, mostly for replacing bridges and ADA improvements. She also announced MetraTracker.com that allows riders to track trains in real time and plan trips. She said schedule changes were also made in December to increase more mid-day trains on the UP Northwest Line.

President Darch asked if Metra will be tracking CMAP's Plan of Action for Regional Transit (PART) since they are not directly part of the committee. Ms. Dote said that she can get updates from Metra's planning department and report back to the committee. President Darch raised the issue of several recent assumed suicides along the NW line, and was wondering if Metra had any suggestions on how to try and prevent this. Ms. Dote noted that Metra police try to patrol those areas; however, due to the size of the police force, she noted the difficulty to do that everywhere. Ms. Diaz also added that Cook County created a Cook County Rail Safety group and is looking to do more outreach on suicide prevention.

g. Pace

Mr. Andrews reported that ridership is currently at 65-70% of pre-pandemic levels. He highlighted that recruitment is a top priority for Pace and mentioned the success of the first Hire on the Spot event of the year.

Mr. Fowler mentioned that if Pace was interested in doing a training partnership or Hire on the Spot event through Oakton College where NWMC offices are located, he would be happy to help facilitate planning efforts.

h. **RTA**

No report.

IV. Changes to Northwest Council Functional Classification Procedures

Staff presented a memo detailing approved changes to the Chicago Metropolitan Agency for Planning's Surface Transportation Project Methodology scoring, as well as proposed changes to Active Program Management guidelines. Ms. Johnson noted that the next Call for Projects will begin earlier in October rather than January.

V. Northwest Council Surface Transportation Program A. Current Program Update

Staff provided an overview of the current program, noting any changes since the previous meeting.

B. Cost Increase Request – Arlington Heights

The Village of Arlington Heights requested an increase of \$1,102,000 for CON/CE for the Wilke Road resurfacing project currently programmed in FFY 2023. Staff reported that there is no funding currently available to accommodate the village's request.

C. Approval of Current Program

Mr. Townsend moved approval of the current program. Mayor Hayes seconded the motion, which was unanimously approved.

VI. Proposed Changes to STP Methodology

Staff presented a summary of changes proposed by the STP Methodology Working Group that met on November 10. Mr. Ottesen suggested that the committee should restate its objectives and prioritize more substantial projects that add capacity rather than resurfacing and other minor projects. Mr. Bragg and Mayor Hayes concurred, with others noting that funding consideration should also be given to smaller communities that have need, but perhaps not larger construction projects. Ms. Johnson said that staff would convene another meeting of the working group to discuss and recommended participation at the meeting by all members of the council. The committee concurred.

VII. Other Business

The committee scheduled the next meeting for Friday, April 28 at 8:30 a.m. at the Barrington Village Hall.

Mayor Hayes moved to adjourn the meeting at 9:30 a.m. Mr. Bragg seconded the motion, which was unanimously approved.

Plan of Action for Regional Transit (PART)

As directed by Public Act 102-1028, CMAP is developing the <u>Plan of Action for Regional Transit</u> (PART) report, which will be a set of legislative recommendations to strengthen the regional transit system. This report must be approved by CMAP's Board and MPO Policy Committee before it is submitted to the General Assembly and Governor's Office by January 1, 2024. The recommendations will discuss topics including: improving transit through enhanced bus service, enabling fare integration, and other measures; identifying sustainable revenues for the system through changes to the sales tax and other mechanisms; and exploring what governance reforms are needed to enact these desired changes.

The PART report will also leverage findings and input from the RTA and its <u>Transit is the Answer</u> strategic plan, as well as CMAP's <u>Mobility Recovery</u> project. CMAP is also required to assemble a steering committee comprised of business, civic, labor, and environmental stakeholders who will help guide development of the recommendations. The PART steering committee have held two meetings, and will next be convening on Wednesday, May 24th. Program Status Updates

CRRSAA Program

On December 27, 2020, Title IV of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) was enacted. This Act resulted in the allocation of \$42,647,247 to be programmed and managed by CMAP. In the fall of 2021, the STP Project Selection Committee and local councils of mayors selected <u>33 individual project phases</u> for CRRSAA funding. The <u>Regional CRRSAA Status Report</u> and <u>Regional CRRSAA Accounting Summary</u> were updated in February 2023.

Safe Travel for All Roadmap (STAR)

CMAP's STAR program aims to improve the region's traffic safety environment. It will continue and build on the work of the Safety Action Agenda and align the effort with new federal funding opportunities including: the development of policy related to speed management, bicycle and pedestrian safety; the creation of safety action plans for qualifying local partners, the dedication of resources to planning and implementing complete streets projects and the creation of data resources for partners to better address safety.

Northeastern Illinois was awarded a \$5 million grant to improve traffic safety across the region. The joint application submitted by CMAP, IDOT, and the region's counties will fund a comprehensive, regional program called <u>Safe Travel for All Roadmap</u> (STAR), which will provide a framework for safety research and programs to make northeastern Illinois safer for all travelers.

CMAP Products and Data

Greenhouse Gas Emissions Inventory and Local Summaries

An updated <u>greenhouse gas emissions inventory</u> using 2019 data is available. This shows that between 2010 and 2019, overall greenhouse gas emissions in northeastern Illinois decreased by 9 percent. While this is progress, the region has a shared goal of reducing emissions by 5 percent annually through 2050, and it fell 36 percent short of the goal. <u>Individualized data summaries</u> by county, community, and Chicago neighborhood that provide a snapshot of emissions from the building, transportation, and waste sectors are also available.

Improving Accessibility in the Region

CMAP has launched a program to help communities in northeastern Illinois improve accessibility for their residents and visitors with disabilities. IIJA booklet and resources for communities

CMAP has launched an <u>online resource</u> to provide communities and partners with the essential information they need to know about IIJA and its benefits to the region. This includes funding estimates for existing transportation programs as well as new programs that can make our regional transportation system stronger and more resilient for the next generation of users.

CMAP has also been working with partners and stakeholders to prioritize and achieve consensus around sustainable solutions to our region's transportation challenges. The highest priority projects for the region are reflected in the <u>IIJA booklet</u>. These projects align with the <u>core principles</u> that guide IIJA and our region — inclusive growth, resilience, and prioritized investment.

From Our Partners

Streamlined Environmental Survey Screening Process

On March 7, 2023, IDOT released <u>Circular Letter 2023-08</u>, which details significant improvements and changes made to streamline the process of environmental surveys to improve review time. Recent Bureau of Design and Environment (BDE) policy changes allow local projects to now be screened for natural and cultural resources by certain qualified and trained Central Office Bureau of Local Roads and Streets (CBLRS) Staff. The intent of the screening process is to also determine which projects must be submitted for more detailed surveys via the BDE Environmental Survey Request (ESR) process. For new projects which have not previously submitted and ESR and are not already within the BDE ESR queue, the new screening processes became effective on all documents submitted after March 6, 2023.

Vulnerable Road User Safety Assessment

On March 15, 2023, IDOT released <u>Circular Letter 2023-10</u>. With the passage of IIJA, IDOT is required to assist and support LPAs to perform a Vulnerable Road User (VRU) Safety Assessment as part of the state's Highway Safety Improvement Plan. The law establishes that the VRU Safety Assessment must be completed no later than November 15, 2023.

National Bike & Roll to School Day

Registration is now open for the 12th annual National Bike & Roll to School Day. The event will take place on **May 3, 2023.** There are currently 19 registered events in Illinois. Funding Opportunities

2023 Special Programs Assistance Conference (EDP, ITEP, and SRTS)

On March 13, 2023, IDOT released <u>Circular Letter 2023-09</u> announcing that the Special Programs Unit will be holding informational conferences in each IDOT district this spring to present three grant programs that could help fund your next transportation project – Economic Development Program (EDP), Illinois Transportation Enhancement Program (ITEP), and Safe Routes to School Program (SRTS). IDOT staff will be available for two days in each IDOT District area to offer general information about each program and answer your specific questions one-on-one to help you take advantage of funding available from these programs. Meetings in District 1 will be held **May 23 - 24** at the IDOT District 1 building in Schaumburg and **May 25 - 26** at the Orland Park Civic Center. Meetings in District 3 will be held **May 16 - 17** at the IDOT District 3 office in Ottawa. Links to register for the morning sessions and to reserve individual appointment slots are available on the ITEP and <u>SRTS</u> webpages.

Transit Planning Funding

On April 10, 2023 IDOT released a <u>NOFO</u> for a competitive grant program that aims to expand safe, equitable access to public transportation throughout the state. Selected projects will feature transit opportunities while furthering the goals of IDOT's <u>Illinois Long-Range Transportation Plan</u>. A An informational webinar to explain the grant program and provide assistance to prospective applicants will be held on April 18 at 10 a.m. CST. Join the event <u>here</u>. Applications are due by **May 24, 2023** and must be submitted through IDOT's transit grants management platform, <u>BlackCat</u>.

Charging and Fueling Infrastructure (CFI) Discretionary Grant Program

On March 24, 2023, IDOT released <u>Circular Letter 2023-11</u> announcing the Charging and Fueling Infrastructure (CFI) Program. CFI offers up to \$700 million from Fiscal Years 2022 and 2023 to strategically deploy electric vehicle (EV) charging infrastructure and other alternative fueling infrastructure projects in urban and rural communities in publicly accessible locations, including downtown areas and local neighborhoods, particularly in underserved and disadvantaged communities. This program provides two funding categories of grants: Community Charging and Fueling Grants (Community Program); and Alternative Fuel Corridor Grants (Corridor Program). Applications are due by **May 30, 2023.** A recording of the March 22, 2023 <u>webinar</u> is now available.

FY23 Safe Streets and Roads for All (SS4A)

On March 31, 2023 the US DOT released a <u>NOFO</u> for the <u>SS4A grant program</u>. The NOFO is summarized in IDOT <u>Circular Letter</u> 2023-12. Funds will be awarded on a competitive basis to support planning, infrastructure, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users. SS4A is a direct recipient program, therefore funds will not pass-through IDOT. Applications must be submitted via Valid Eval by **July 10, 2023**. Wildlife Crossing Pilot Program (WCPP)

On April 4, 2023 the US DOT released a <u>NOFO</u> for the Wildlife Crossing Discretionary Grant Pilot Program (WCPP), which aims to protect wildlife, reduce the number of Wildlife Vehicle Collisions (WVC), and improve habitat connectivity for terrestrial and aquatic species. WCPP grants are available for all project activities, including but not limited to research, planning, design, and construction. The total amount of funding that is available is up to \$111.85M. It is anticipated that 60% or more of the available funds will be award to applicants in rural areas. Applications are due by **August 1, 2023** through <u>www.grants.gov</u>.

Climate Resilience Training Courses

The FHWA's National Highway Institute (NHI) is now offering five new Environmental courses addressing climate change through adaptation and resilience. The target audiences for the courses are primarily transportation personnel who work in engineering, design, and project development/NEPA units in transportation agencies (mainly State DOTs). Introduction to NEPA and Transportation Decision-making

This WBT describes Federal Highway Administration's (FHWA's) approach to the NEPA transportation decisionmaking process. Course lessons include determining the interplay between transportation systems and land use development patterns, the processes and principles that influence integrated transportation and land use planning, and strategies for applying integrated land use and transportation principles to different types and scales of planning and decision-making processes. Target audience includes Mid-level State DOT employees, City and County engineers and planners, MPO staff, transit operators, Federal employees (FHWA, FTA, EPA), resource agency staff, consultants, elected officials, regulatory agency staff, local zoning officials, site designers, citizen activists, developers, media representatives and business leaders.

Pace Awarded CMAP Regional Resilience Award for Project Zero

Award presented as Pace Board of Directors approves electric car charging infrastructure at nine locations

Pace was honored today with the Chicago Metropolitan Agency for Planning (CMAP) Regional Resilience Award for the agency's <u>Project Zero</u> initiative. CMAP Executive Director Erin Aleman presented the award to Pace at the agency's April 2023 Board of Directors meeting. *Project Zero* is Pace's commitment to operating a zero-emission fleet by 2040.

"Project Zero was a major step forward that we all took together," said Pace Executive Director Melinda Metzger. She also noted that "Pace's <u>North Division</u> in Waukegan will be the first garage to be converted to a fully electric fleet. This decision was based on environmental concerns and our ongoing work to create an innovative, equitable, and efficient transportation network for those we serve. Electrification will make an impact in the Waukegan area where a high percentage of riders are low-income, minorities, or from otherwise underserved groups."

Project Zero began with the delivery of Pace's first electric bus in 2022 and the completion of the agency's <u>fleet transition plan</u>. Twenty more buses are scheduled for delivery later this year as Pace develops its facility transition plan and begins work on a network revitalization plan.

Today's meeting also saw the approval of several ordinances, including a contract for the purchase and installation of electric car charging stations to be implemented at nine Pace locations including park-n-ride lots that support bus on shoulder service along I-55 and I-90. Each location will have two charging stations with dual dispensers capable of charging up to 4 vehicles.

The Pace Board also voted to approve ordinances authorizing the permanent implementation of two innovative service changes launched during the Covid-19 pandemic to better meet the needs of Pace passengers. These changes, which have



been in place on a pilot basis, include the expansion of the <u>Naperville-Aurora On</u> <u>Demand</u> service area and a new <u>part-time Vanpool fare structure</u>. Six public hearings were held the week of March 20 and both pilots received positive feedback.

In her report to the Board, Pace Executive Director Melinda Metzger shared several positive updates, including progress on the agency's recruitment efforts and continued ridership growth. The agency will host four more Hire-on-the-Spot events over the next six weeks, including one for <u>Pace's Heritage Division in Plainfield</u> (<u>Thursday, April 20, 10am-2pm</u>) and one for <u>Pace's Northwest Division in Des Plaines</u> (<u>Tuesday, April 25, 10am-2pm</u>).

In addition to <u>bi-monthly Hire-on-the-Spot events around the region and partnerships</u> with local colleges to train the next generation of professional bus operators, beginning April 27 the agency will host weekly Hire-on-the-Spot events at Pace's headquarters in Arlington Heights (550 W. Algonquin Road) every Thursday at 9:30am and 1pm for candidates interested in positions at Pace's <u>Northwest Division</u>. Job seekers will be able to apply and get interviewed at these events. More information about Pace's hiring events can be found at <u>PaceBus.com/careers</u>.

Metzger also shared that for March 2023, Pace ridership increased 4% from March 2022 with the system carrying just over 1.6 million riders. The Pace system continues to experience a steady increase in ridership and the agency's cost-saving and efficient partnerships with transportation network companies (TNCs) continue to successfully augment paratransit service with UZURV and Uber providing more than 6000 trips in March.

The <u>Pace Board of Directors</u> meets monthly in Arlington Heights, typically on the third Wednesday of each month at 9:30am. The Board's schedule, along with agendas, minutes, and video recordings, can be found on the <u>Public Meetings page at</u> <u>PaceBus.com</u>, and meetings are streamed live at <u>PaceBus.com/Streaming</u>.

Transit is the Answer was recently recognized with <u>CMAP's Regional Excellence</u> <u>Award</u>, which spotlights "projects and leaders who exemplify the ingenuity and dedication that makes northeastern Illinois a better place to live, enjoy, work, and do business." The plan was a collaborative effort that drew on feedback and expertise from partners and stakeholders throughout the region and this award reflects those important contributions.

RTA staff continues to communicate to local, state, and federal leaders about the plan and the importance of transit to the region. At the state level, the RTA and all three Service Boards participated in a subject matter hearing on regional transit hosted by the Illinois House Public Safety Appropriations Committee. RTA provided testimony alongside the Service Boards, detailing budgetary challenges and how Transit is the Answer charts a path forward for the region. The Service Boards discussed how they've adapted to COVID and advanced ambitious capital programs to modernize the region's transit system amidst the challenges of the past few years.

Funding available for projects that benefit seniors, people with disabilities

The <u>Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities</u> <u>Program</u> is a federal program that aims to improve mobility for seniors and individuals with disabilities by removing barriers to transportation service and expanding transportation mobility options. The Call for Projects is currently open with a total of \$13,776,009 available for FY2022 & FY2023. Applications must be received by the RTA no later than noon on April 21 via the <u>online application form</u>. Additional details on the Section 5310 program can be found on our website.

PMO Report Highlights

Twice a year the RTA publishes a Project Management Oversight (PMO) report that details major transit investments by CTA, Metra, and Pace and fulfills our oversight role in ensuring that we are efficient stewards of capital funding. There are 107 projects detailed in the <u>December 2022 PMO report</u>, representing more than \$7.56 billion worth of construction, maintenance, and procurement to improve the Chicago region's transit system. Highlights in the region include:

- *Metra*: First phase of Ticket Vending Machine (TVM) installation at selected locations throughout the Metra system
- *Pace*: Technology enhancements to two ADA paratransit services and construction of two new ADA transfer centers in Schaumburg and Calumet City.

Recommendation: Revise the Northwest Council's Functional Classification change procedures based on recommendations from the Technical Committee and STP Working Group.

Issue: Several potential revisions to the Northwest Council of Mayors' Functional Classification Change Procedures have been proposed in response to members' experiences submitting and reviewing requests. The Working Group met on August 2 and November 10 to discuss potential options and refine recommendations for the Technical Committee's review at the January 28 Technical Committee meeting. While other changes to the methodology are being explored further, the Technical Committee expressed support for the set of functional classification changes included in the overall set of recommendations and directed staff to move forward with the changes. Below is a summary of the recommended functional classification changes for consideration by the Technical Committee.

Changes to Functional Class Change Procedures

A. Language in Methodology: The Northwest Council's STP methodology contains language that allows for some degree of grey area when it comes to new applications during a call for projects:

"All projects must be on STP eligible routes. STP eligible routes serve a regional purpose and must serve more than a local land access function. Routes must be designated as a collector or higher."

Working Group Recommendation: Add "at the time of STP application submittal" at the end of the first sentence for clarification moving forward.

B. Functional Classification Change Application: Currently, there is no minimum point threshold for staff to recommend approval for an application from the Northwest Council Technical Committee. Committee members only know an application's score relative to the maximum. Additionally, the Traffic Generators specifies "high schools" as a category, while CMAP's application only lists "schools" in general.

- **a.** Working Group Recommendation: Allow any road segment to request a change, but limit staff recommendations for approval to those that earn 25 points or more on the Northwest Council's internal scoring system (unless they are requesting a downgrade).
- **b.** Working Group Recommendation: Change "high schools" to "schools" in Traffic Generators section to align with the formal application form.

Background: The Northwest Council of Mayors has used the same internal scoring system to evaluate functional classification change requests since prior to 2019. There is no minimum score or existing guidance for the Technical Committee to evaluate the requests. In 2022, the STP Working Group was tasked with adding additional guidance to add to the Council's Methodology to clarify evaluation procedures moving forward.

Recommendation: Staff recommends that the Technical Committee approve the consensus recommendations made by the Northwest STP Working Group as outlined below. Additionally, staff requests that the Committee discuss and consider the project selection criteria for which consensus could not be reached by the Working Group.

Issue: Several potential revisions to the Northwest Council of Mayors STP methodology were proposed in response to members' experiences during the call for projects and functional classification change process. The working group met previously on August 2 and November 10 to discuss potential options and provide feedback for staff to create refined proposals. Staff also received feedback from council members via email.

When presented to the Technical Committee at their January 27 meeting, members expressed concern that the overall goals of the Northwest Council were not being addressed with the proposed changes. The Committee recommended additional discussion of the broader issues and goals of the council before further consideration of changes to the STP methodology.

Below is the current scoring system for the Call for Projects in the Northwest Council. The criteria that were discussed at the March 22 Working Group meeting are highlighted in yellow.

A. Council Goals / Funding Priorities: Establish overall goals of the Northwest Council so that staff can ensure alignment of desired STP changes with stated objectives.

March 22 Meeting recommendation: It was the consensus of the Working Group that the council objectives should focus on larger intersection/reconstruction projects. The match ratio for roadways and intersections will stay the same with an 80/20 federal/local split. Similarly, for resurfacing, LAFOs, and LASOs, the match ratio will remain at a 75/25 federal/local split.

Action Requested: Approve the Council's focus on prioritizing intersection/reconstruction projects rather than resurfacing projects.

B. Funding Cap: The Northwest Council currently limits the federal contribution for each project to \$3.5 million total. There have been some requests to raise this threshold.

March 22 Meeting recommendation: It was the consensus of the Working Group that roadway and intersection projects would still have a cap of \$3.5 million however would have the option to request up to \$5 million with approval from the Technical Committee. Resurfacing, LAFOs, and LASOs would be limited to the cap of \$3.5 million.

Action Requested: Approve funding cap increase to \$5 million for roadway and intersection projects with approval from Technical Committee.

C. Complete Streets: During both calls for projects held to date, requests have been made to change how this category is scored. Below is the scoring as it currently stands:

Previous working group recommendation:

Keep total points available the same. Change scoring for the adoption of a Complete Streets policy from 30 points to 25 points. Lower the points awarded for new or upgraded elements to 15 points from the current 20 points. Keep the point amount for replacement/maintenance and documented exceptions the same. The remaining 10 points will be made into a "bonus" category awarded to the top 3 projects in terms of the number of new or upgraded Complete Streets elements.

Staff used this system to rescore a previous call for projects and assess the impact of the potential new scoring system. It was determined that this system would help achieve the goals of making the category more meaningful in modest ways while not penalizing projects that might not have the capability to make significant Complete Streets improvements. Staff did not receive negative feedback on this solution following this information being distributed to the working group via email.

March 22 Meeting recommendation: It was the consensus of the working group to reduce the amount of points a project would receive if the community had adopted a complete streets policy. This was based on the assumption that all council members already have a complete streets policy. However, Park Ridge, Inverness, and South Barrington do not currently have a complete streets policy. It was suggested to allocate only 15 points for having a policy, while increasing the points for new or upgraded complete streets elements to 20 points, and replacement or maintenance of existing complete streets infrastructure to 15 points. The Technical Committee will need to decide whether to proceed with this plan, given that three Council members do not have complete streets plans in place.

Action Requested: Discuss and determine if adopted Complete Streets Policy points should be decreased given that some Council members don't currently have a plan. Determine what the new distribution of points should be and should additional points be given to the Top 3 projects?

D. Safety Data: Currently, the safety tiers data for local roads used by the Council is from 2017. IDOT has updated the state route data for 2020, but the latest available data will always be a couple of years behind. Staff suggested that the council align with some of CMAP's recent proposals. Below is the proposed reallocation:

Up to eight additional points will be awarded based on the percentage crashes that occurred within the project limits that are one of the high risk crash types and the percentage of those high risk crashes that resulted in a fatality or serious injury:

-Percentage of speed related crashes within the project limits x 2 points
-Percentage of crashes involving vulnerable users within the project limits x 2 points
-Percentage of speed related crashes resulting in a fatality or serious injury x 2 points
-Percentage of vulnerable user crashes resulting in a fatality or serious injury x 2 points

Crash data used to determine these percentage will be the most recent five years for which data was available from IDOT <u>or</u> provided by the applicant. No points will be given for speed-related or vulnerable user-involved crashes if the project scope does not include countermeasures to address reduction of these types of crashes. A crash that was both speed related and involved a vulnerable user would be counted in both parts of this scoring.

March 22 Meeting recommendation: The total number of points in this category is 35 points. One recommendation was to decrease the Safety Need component, maintain the Safety Improvement component, and allocate up to eight additional points based on the percentage of crashes that occurred within the project limits. There was no agreement among the working group on whether to implement the proposed scoring for this category. Therefore, further discussion is necessary.

Action Requested: Does the committee want to proceed with the additional points for high risk crash types? Further discussion requested.

E. Pavement Data: CMAP has notified Planning Liaisons that they will halt collection of pavement condition data due to its redundancy with <u>IDOT's pavement data collection</u>. IDOT collects pavement data according to federal standards (CMAP's data used Pavement Condition Index or PCI). Besides changes to the data source used, the Working Group should discuss any desired changes to the scoring matrix. Below is the current scoring (based off of PCI data):

March 22 Meeting recommendation:

It was the consensus of the working group to use IDOT's Condition Rating Survey. However, communities would be eligible to use their own pavement condition data if it is more up to date than the IDOT data. The flexibility to choose between the two was an important factor for many members of the working group. Scoring would remain unchanged for this category.

Action Requested: Approve recommendation to keep points the same and use IDOT's Condition Rating Survey. However, community data may be used instead if it is more up to date then IDOT's.

F. Level of Service: Currently, all intersection and reconstruction project types are subject to Level of Service (LOS) scoring, even though many reconstruction projects do not address Level of Service improvements. This puts many reconstruction projects at a disadvantage, since they almost always automatically receive a 0 in this category. The category is worth 15% of total points available.

March 22 Meeting recommendation: The consensus of the working group at this time is to leave the Level of Service project selection criteria unchanged and not replace it with Green Infrastructure/Resilience and/or Freight Planning factor categories.

Action Requested: Determine if the Level of Service project selection criteria should remain unchanged.

Background: The Northwest Council of Mayors first approved a new STP scoring methodology in response to federal requirements in September 2019. The Council held its first call for projects (CFP) using the new system in January 2020. Following the first call for projects, several changes were proposed and discussed by a working group composed of Council staff members. Proposed changes included several minor changes to the application as well as more significant changes to the Complete Streets category. The Technical Committee was presented with the proposed changes and elected to approve the minor clerical changes while deferring any for the Complete Streets category in favor of allowing another CFP to proceed under the original scoring and reassess in the future.

In November 2021, the working group met again to discuss a change to allow cost increases for Phase II engineering. This change was approved and officially incorporated into the methodology in February 2022. After holding another CFP in January 2022, additional changes to the council's methodology were requested, and the working group was convened to discuss and recommend solutions.
