Call to Order/Introductions

Mayor Johnson called the meeting to order at 8:30 a.m.

September 28, 2023 Meeting Minutes

Mayor Sanoica moved approval of the September 28, 2023 minutes. Trustee Israel seconded the motion, which was unanimously approved.

Mr. Haadsma reported that the final programs for the Shared Fund, CMAQ, and TAP programs were approved by CMAP on October 11. These included four projects in the North Shore Council of Mayors with over \$4 million in funding, and seven projects in the Northwest Council of Mayors with over \$23 million in funding.

Mayor Craig asked about CMAP's next steps for PART and clarification on who would be receiving the report. Mr. Haadsma shared that the report would be going to the Governor's office and was uncertain about who in the legislature would be receiving the report and will follow up as to the recipient. Mayor Johnson requested CMAP to provide additional information about the next steps in the process.

b. Cook County Department of Transportation and Highways

Mr. Ruehle stated Cook County had no additional information beyond the report included in the agenda.

c. IDOT Highways

IDOT was not in attendance. Report was attached to the agenda.

Mayor Johnson emphasized that a subgroup was previously formed regarding IDOT issues, and asked NWMC staff to submit a note to IDOT to attend the November Transportation Committee meeting to answer any questions. Trustee Israel asked about other committee experiences with IDOT. Mr. Czarnota and Mr. Larson indicated that IDOT BLR has been in attendance for the Technical Committee. Mayor Craig asked whether Transportation Committee matters with IDOT are now being handled by the Technical Committees. Mr. Fowler said getting IDOT attendance at Transportation Committee has been difficult but would reiterate the ask. Trustee Israel inquired whether the difference in understanding what Transportation Committee versus Technical Committee may be creating difficulty assuring attendance. Mr. Fowler said IDOT turnover may be the issue. Mayor Craig indicated that the Transportation Committee's main focus is policy versus the project nature of the Technical Committees and need IDOT's voice in the discussion. Trustee Israel confirmed that the Transportation Committee is not an ancillary project, but one dealing with policy and process. Mayor Johnson reiterated the need to coordinate with IDOT at the Transportation Committee.

d. Illinois Tollway

Ms. Passi reported on the I-PASS Assist program and the Tollway's availability to promote materials, help fill newsletters, and increase outreach to member communities.

Trustee Benton asked for comment on the Tollway's transition from transponders to stickers. Ms. Passi responded that the transition discussion is still ongoing and will bring additional information to the next meeting.

e. Metra

Ms. Dote reported on Metra's proposed budget items, focusing on the \$1.1 billion operating budget including fare restructuring. She noted ridership forecast in the budget is 44% of pre-pandemic riders and assumes 10% year-over-year growth (increasing to 54%, 64%, etc.), for 40 million rides projected in 2024. Metra has a \$570 million capital budget, with 63% of that cost on bridges, parking, yard improvements, and railcars. Metra will be having upcoming budget

Attachment A hearings, with one in Lake County on November 1, a November 1 Chicago livestream, and a November 2 hearing in Hanover Park. Mayor Craig commended Ms. Dote's work for Metra.

f. Pace

Mr. Andrews reported on Pace's proposed 2024 budget, and how Pace is targeting increased frequency improvements along fixed routes to meet off-peak demand, with gradual implementation throughout the year and dependent on operator recruitment. He shared that the 2026 fiscal cliff is at the forefront of Pace's planning. He said this year's budget is balanced, but the combined \$730 million shortfall doesn't allow for new investments or innovations to meet community demands.

Mr. Andrews also discussed the launch of Pulse Dempster Line, plan to advance Halsted 95th Street Pulse lines next year, service integration into the Transit app, plan for network reform to address changes in ridership demand, an ADA Paratransit budget with no fare increases and free fare on fixed route for ADA certified riders. He also reported that the expanded Rideshare Access Program via Transportation Network Companies beyond traditional paratransit as ADA Paratransit is above 100% pre-pandemic ridership numbers.

Mr. Andrews said that Pace is making its Waukegan garage fully electric with delivery of electric vehicles and charging equipment, as well as installing charging equipment at its Plainfield garage and installing EV charging centers at its Park-n-Rides. He said the agency is also renovating the Northwest Transportation Center to include the new ADA Transfer Center, and centering the Northwest Division in Wheeling in its Zero Emissions Facility Plan.

Mayor Johnson thanked Mr. Andrews for all of the information and requested career change support and collaboration with high schools for alternative career paths. Mayor Johnson asked about Pace's plan to offset the 2026 shortfall and how it intersected with ADA needs. Mr. Andrews responded that as Pace provides the ADA service to complement the fixed-route system, there is concern that there may be an impact on how to provide ADA if fixed-routes are also cut but was uncertain about the actual steps.

Mayor Sanoica asked Pace to involve community partners in the network revision process and how municipalities can best partner with Pace to boost ridership. Mayor Sanoica specifically pointed out the elimination of Pace Route 696 and the Rolling Meadows-Arlington Heights On-Demand service area's lack of inclusion of Rolling Meadows west of Route 53. Mr. Andrews responded that the revision study will help identify areas for service changes and Pace is currently making changes to its On Demand zones.

g. RTA

Ms. Johnson reported changes to RTA's Citizens Advisory Board bylaws based on the Strategic Plan process to increase activity, engagement and ridership composition on the board. Notably, she said voting members will be County/Chicago DOTs, Service Board reps, and a member from The Network, with additional non-voters on the Board as rider representatives.

IV. RTA Access to Transit Presentation (Attachment G)

Ms. Johnson presented RTA's Access to Transit Program which funds infrastructure improvements around community transit stations and bus stops. The Access to Transit Call for Projects is open October 16 through December 15. Phase 2

Engineering, Construction, and Construction Engineering grants will cover small scale capital improvements up to \$1 million that implement a pre-existing plan/study, with prioritization for high need communities. She said awards will be identified in February 2024, but are contingent upon RTA's successful CMAQ FFY2026-2030 application.

V. Integration of Accessibility in Council of Mayors Methodologies

Mr. Czarnota shared the recent Public Right of Way Accessibility Guidelines (PROWAG) rulemaking and its impact on municipal right of way compliance. He emphasized that PROWAG compliance will be required as a policy and design standard within the next 4 years, and integration of PROWAG requirements into Council of Mayor methodologies will be necessary to apply for federal funding.

VI. ADA Transition Plans, Council of Mayors Methodologies, and Municipal Vulnerabilities

Mr. Larson discussed the ADA Transition Plan compliance rate among member communities, showing that several communities still need to complete Transition Plans. He indicated that this could place those communities at a disadvantage in future Call for Projects as there will be upcoming CMAP requirements to include ADA Transition Plan/Compliance in Council of Mayor evaluation methodologies. Finally, Mr. Larson indicated that staff has been informed of a possible large-scale, multimunicipality disability group lawsuit in development to enforce the ADA Transition Plan, and that communities should be prepared for potential Department of Justice Project Civic Access audits.

VII. Community Surveys on Weather Maintenance and All-Ages Access

Mr. Larson discussed staff development of a survey about how member communities plan for transportation facility maintenance during all weather conditions, especially for active transportation facilities, and whether the facilities are designed for users of all ages.

VIII. Other Business

There was no other business.

IX. Next Meeting

Mayor Johnson announced that the next meeting of the NWMC Transportation Committee is scheduled for Thursday, November 30 at 8:30 a.m. at the NWMC offices and via videoconference.

X. Adjourn

Trustee Benton moved to adjourn the meeting at 9:37 a.m. Mayor Craig seconded the motion, which was unanimously approved.

Plan of Action for Regional Transit (PART)

As directed by <u>Public Act 102-1028</u>, CMAP has developed a <u>Draft Plan of Action for Regional Transit</u> (PART) report, a set of legislative options to strengthen the regional transit system, which is facing a funding crisis that has the potential to decimate service, cripple our regional and local economies, and diminish quality of life. The PART report leverages findings and input from the RTA and its <u>Transit is the</u> <u>Answer</u> strategic plan, as well as CMAP's <u>Mobility Recovery</u> project. Recommendations for system improvements and funding approaches are available on the <u>PART web page</u>.

As part of this process, CMAP was also required to assemble a <u>steering committee</u> comprised of business, civic, labor, and environmental stakeholders who helped guide development of the recommendations. The PART steering committee met five times. At their joint meeting on October 11, 2023, the CMAP Board and MPO Policy Committee authorized the submission of the PART report to the General Assembly and Governor's Office for consideration.

Surface Transportation Program

The <u>STP Project Selection Committee</u> last met on November 2, 2023. The committee is scheduled to meet next on **February 15, 2024** at 9:30 am. <u>Meeting Materials</u> are posted on CMAP's Legistar page one week in advance of the meetings. Safe Travel for All Roadmap (STAR)

CMAP's STAR program continues to work to improve regional travel safety with assistance, resources and policy development. CMAP's Speed management paper is in the final stages of review to share with partners and the public. Our *Safe Streets and Roads for All* Regional Safety Action Plan program will kick off before the end of the year, with six county-led safety action plans across the region. The procurement process is nearing completion, with staff and county representatives reviewing 11 proposals for the 6 county safety action plans, hoping to align the responses with county needs and budgets. The Regional Equity and Engagement consultant responses are also under review.

Explore the CMAP Data Hub

CMAP's <u>Data Hub</u> provides vetted and trustworthy information about northeastern Illinois so local governments, community organizations, academic researchers, businesses, and more can learn and make informed decisions about their communities. The Data Hub allows you to search or browse by categories and tags. You can find tables or shapefiles for transit routes and stops, greenhouse gas emissions, economically disconnected and disinvested areas, bikeway inventory system, and more!

2023 Community Data Snapshots

Updated CMAP <u>Community Data Snapshots</u> are now available. The annual snapshots provide datadriven profiles for every county, municipality, and Chicago Community Area (CCA) in our region. The snapshots include updated demographic, socioeconomic, and employment data from the American Community Survey (ACS) datasets, updated land use summaries using data from the <u>Land Use Inventory</u>, and updated estimated vehicle miles traveled per household. Staff has also created a <u>toolkit</u> to help communities share this information.

Improving Accessibility in the Region

CMAP has launched a program to help communities in northeastern Illinois improve accessibility for their residents and visitors with disabilities. This <u>CMAP webpage</u> provides communities and partners with essential information about improving accessibility and complying with the Americans with Disabilities Act. CMAP also conducts a series of free ADA trainings, which cover ADA and Title II requirements, completing a self-evaluation, the role of an ADA coordinator, and developing a transition plan. Additionally, the U.S. Access Board has released a <u>series of videos</u> on Public Right-of-Way Accessibility Guidelines (PROWAG). These videos review the accessibility requirements to make sidewalks, crosswalks, shared use paths, on-street parking, and other pedestrian facilities accessible to people with disabilities.

IIJA Booklet and Resources for Communities

CMAP has launched an <u>online resource</u> to provide communities and partners with the essential information they need to know about IIJA and its benefits to the region. This includes funding estimates for existing transportation programs as well as new programs that can make our regional transportation system stronger and more resilient for the next generation of users.

CMAP has also been working with partners and stakeholders to prioritize and achieve consensus around sustainable solutions to our region's transportation challenges. The highest priority projects for the region are reflected in the <u>IIJA booklet</u>. These projects align with the <u>core principles</u> that guide IIJA and our region — inclusive growth, resilience, and prioritized investment.

IDOT 2022 Pavement and Structure Data

New pavement and structure condition data, collected in 2022, is available on the IDOT website <u>here</u>. At the bottom of the page, you can download a zip file, which contains Excel and GIS layer packages containing the data.

2022 Statewide Crash Data

On June 20, 2023, IDOT released <u>Circular Letter 2023-18</u> regarding the 2022 statewide crash data and safety portal. The information can be accessed by logging into <u>IDOT's Safety Portal</u>, which provides access to search and retrieve individual crash reports, view the location of a crash on a map, access the full 10-year retention period for historical and trend analysis purposes of sites and crashes, and generate standardized summary reports of crash data based on various input parameters. Additional crash data may be requested by contacting the Bureau of Data Collection at <u>DOT.DTS.DataRequests@illinois.gov</u>. Additionally, the 2021 Illinois <u>Crash Facts and Statistics Publications</u> are also available on the IDOT website.

Bicycle Facility Inventory System

On March 15, 2023, IDOT released <u>Circular Letter 2023-10</u>. With the passage of IIJA, IDOT is required to assist and support LPAs to perform a Vulnerable Road User (VRU) Safety Assessment as part of the state's Highway Safety Improvement Plan. The law establishes that the VRU Safety Assessment must be completed no later than **November 15, 2023**. You can help improve safety by identifying areas in your community that may be unsafe for bicyclists, pedestrians, or other vulnerable road in a new <u>online map</u>.

2024 Annual Budget Update and Approval

The November Metra Board of Directors Meeting, the Board approved a \$1.1 billion operating budget for 2024 that includes a major revision to the agency's fare structure and a new mix of fare products. It also approved a \$574.9 million capital budget that continues significant investment in railcars, bridges, and stations.

The operating budget is 4.9% higher than the 2023 budget (excluding \$65 million in added costs that will be reimbursed by Northern Indiana Commuter Transportation District, or NICTD). The increase is largely driven by expected inflationary (general, medical premiums, fuel, insurance) and contractual (union agreements) increases.

The operating budget incorporates a revision to the Metra fare structure that was proposed this summer. Under the new structure, which will take effect on Feb. 1, 2024, fares will be equal to or lower than pre-pandemic levels. Major changes include:

- Replacing the existing 10-zone distance-based structure with a simplified four-zone structure.
- Discontinuing the promotional the \$6 and \$10 Day Passes and \$100 Super Saver Monthly Pass.
- Replacing the 10-Ride Ticket with a Day Pass 5-Pack available only in the Ventra app;
- Discontinuing "incremental fares" a surcharge to travel beyond the zones indicated on a ticket.

The operating budget projects Metra will start the year at 47% of pre-pandemic (2019) ridership and finish the year at about 54% of pre-pandemic levels. This results in a projection of \$243.9 million in system-generated revenues, mostly fares. To cover the rest of its budgeted operating costs, Metra will use \$560.4 million in regional sales taxes and \$223.7 million in federal COVID-relief funding.

The capital budget of \$574.9 million funds 97 projects throughout the system. About 63% of the budget will fund work in four categories:

- Bridge and retaining wall replacement and rehabilitation: \$143.8 million
- Stations and parking Rehabilitations: \$77.5 million
- Yard improvements, including facility acquisitions: \$71.1 million
- Railcar rehabilitation \$67.6 million

The capital budget is funded by:

- \$252.1 million in federal formula funding
- \$117 million USDOT Mega grant for Union Pacific North Line bridges
- \$73.8 million in Illinois PAYGO funds
- \$130 million in RTA bonds
- \$2 million in RTA Section 5310 funds

Metra Receives \$169.3 million in CMAQ Grants

Metra will receive the largest discretionary grant in its history – a 169.3 million federal Congestion Mitigation and Air Quality Improvement (CMAQ) grant – to buy battery-powered, zero-emission trainsets. Metra will be among the first in the nation to operate the innovative green technology.

A trainset is a group of permanently or semi-permanently coupled railcars powered by a propulsion system without a separate locomotive, with operator controls at either end so they can quickly change directions. Trainsets powered by batteries are currently in use in Germany, France and Australia, and Metra wants to explore whether they could work here. It issued a Request for Proposals (RFP) for battery-powered trainsets in September 2022 and is currently reviewing proposals it received in response.

CMAQ funding will support the purchase of up to 16 trainsets, adding a new type of propulsion to Metra's fleet that could accelerate and brake faster than its traditional trains. The lower-capacity trainsets could be a more economical and environmentally friendly way to provide the same level of service or better, particularly during off-peak times, and could play a significant role in helping Metra achieve its vision to provide more frequent all-day service.

Buying the trainsets would allow Metra to retire some of its oldest, most polluting diesel locomotives, which are well beyond their useful life, and eliminate tons of carbon emissions. It would also allow Metra to retire some of its oldest railcars.

The largest discretionary award comes after Metra's record-breaking haul in 2022, when it secured 204.1 million in competitive federal grants for Metra projects. The amount included the previous record for a discretionary award – 117 million for the next phase of the UP North Line bridge replacement program.

Metra Holiday Train

Metra is hosting a series of Holiday Trains throughout the region. Tickets for the Metra Electric, BNSF, Milwaukee District West, Rock Island and Union Pacific Northwest are sold out, however, we have added one more Holiday Train to the Union Pacific North Line.

The event will be hosted on the North Line on Saturday, December 16. Starting in Waukegan, the train will make a 11:10 a.m. departure heading inbound and making stops at Great lakes,

Lake Bluff, Lake Forest, Highland Park, Ravinia, Glencoe, Winnetka, Wilmette, Central St., Davis St., Main St., Rogers Park, and Ravenswood before arriving at a decorated Ogilvie Transportation Center at 12:30 p.m.

Tickets are only \$5 and go on sale November 30 at 7 a.m. The Holiday Trains can also be spotted in service throughout the region this holiday season.

2024 regional transit budget advances

The <u>RTA's regional transit budget development</u> cycle continues as the Service Boards have submitted their proposed operating budgets and capital programs to the RTA and have held public hearings throughout the region. The Service Boards presented their adopted budget submissions to the RTA Board at the November 16 meeting, and the RTA will continue presenting the proposed regional operating budget, 2-year financial plan, and 5-year capital program at county board meetings throughout the next two months. The RTA is holding a virtual regional public hearing on the proposed budget on Thursday, December 7 (pre-registration is required). The final proposed regional budget will be presented for consideration by the RTA Board at their December 14 meeting.

RTA developing state legislative agenda

To build support for state legislative action to address the projected fiscal cliff for transit and advance other RTA policy goals outlined in *Transit is the Answer*, RTA Government Affairs staff have developed a <u>state legislative agenda</u> for the agency. This agenda will evolve over time as staff continue to collect feedback and insight from legislators, the RTA board, the <u>*Transit is the Answer* Coalition</u>, and other key stakeholders. The RTA's policy priorities include fully funding the region's transit system; developing a funding structure that is less reliant on rider fares; pursuing reforms and efficiencies that will improve operations; and pursuing reforms to how the state plans, evaluates, and prioritizes transportation projects.

RTA launches free fare program for survivors of domestic violence

In October, the <u>RTA provided 25,000 transit passes</u> loaded with \$20 each to The Network, an Illinois membership organization advocating to end domestic violence through training, education, and policy advocacy. The Network will distribute the cards to over 50 service providers throughout the RTA region. Survivors who are not currently connected with a service provider are encouraged to call the Illinois Domestic Violence Hotline at 800-799-7233. The initiative is the result of the <u>2023</u> transit omnibus package, which was signed into law in July.
