III. Metropolitan Planning Council Presentation

Mr. Glover of the Metropolitan Planning Council presented on the organization's recently released report, "Toward Universal Mobility." Mr. Glover described the current conditions of fragmented mobility options for people with disabilities and reviewed the report's proposals to improve mobility options for the target population.

IV. Northwest and North Shore Councils of Mayors FFY 2021-2025 STP-L Update Mr. Pasquini updated the committee that the North Shore Council was presented a preliminary program for FFY 21-25 on April 9. Illinois at risk of a census undercount, especially in communities of color

Our region is behind in our 2020 Census response, and the U.S. Census Bureau is ending field data collection on September 30, 2020 — a month early. CMAP just published <u>analysis</u> detailing northeastern Illinois' risk of a census undercount, especially in communities of color, and the potential loss of critical federal resources to municipalities.

To increase our census count by September 30th, we are asking all of our region's 284 municipalities to share the effects of an undercount and encourage your networks to fill out the census. To assist with this effort, CMAP has created this <u>social media toolkit</u>, and we are asking you to use it as a resource to encourage a complete count in your community.

Calls for Projects

CL2020-14 Illinois Special Bridge Program FY2026

IDOT intends to add a <u>FY 2026 local increment</u> to the Illinois Special Bridge Program (ISBP). Funding is for existing local and state major highway bridges that meet STP-Bridge eligibility. The project cost must total a minimum of \$1,000,000, however only the construction and construction engineering cost will be eligible for funding from the Special Bridge Program. Applications are due by **October 6, 2020** and selected projects will be released with IDOT's proposed FY 2022 – 2027 Highway Improvement Program in the spring of 2021. Illinois Transportation Enhancement Program (ITEP)

Approximately \$105 million in federal and state funding will be awarded in the next ITEP cycle. The call for projects will be open from **August 21 to November 2, 2020**, with awards expected to be announced in March 2021. The maximum per-project award is \$2 million. A minimum 20% local match is required for engineering and construction phases and 50% for right-of-way and easement acquisition, unless the applicant qualifies for state matching funds based on high-need criteria. At least 25% of projects funded will be directed toward projects in high-need communities and the local matching funds required shall be determined based on a sliding scale based on the Community Map score. 2020 – 2022 Urban & Community Forestry Grants

The Morton Arboretum is administering a <u>grant program</u> to offer urban and community forestry grants of \$3,500 to \$20,000 to municipalities, tribal governments, park districts, counties, and other units of local government in Illinois. Awardees are required to provide a 100% cash or in-kind match to their grant funds. This grant provides funds for an inventory of public trees and an accompanying urban forestry management plan. For this cycle, there are no funds available for tree planting. However, tree planting may be used as match with some limitations, as noted in the <u>Request for Proposals</u>. Municipalities are required to pass a tree preservation / protection ordinance before the end of the grant period and assistance to complete this requirement will be provided by The Morton Arboretum at no charge. Applications are due **Friday, September 25th, 2020 at 5:00 p.m.** and the grant period ends Monday, August 1, 2022. See the Chicago Region Trees Initiative (CRTI) website for <u>more details</u>.

IDNR Boat Access Area Development Program Grants

The <u>Boat Access Area Development (BAAD) Program</u> is a state-financed grant program that provides funding assistance to local government agencies for acquisition and/or development of land for public boat and canoe access areas in Illinois. The program can provide up to 100 percent reimbursement funding assistance on approved development project costs and 90 percent reimbursement on land acquisition costs. The local agency must demonstrate and possess the ability to finance the costs of an approved project prior to receipt of grant funds. This program is funded through a percentage of the state's marine motor fuel tax and registration fees.

The program is managed in Illinois by the IDNR and applications must be submitted to the IDNR by 5:00 p.m. on **Oct. 2, 2020**. More information is available in the <u>Notice of Funding Opportunity</u>, on the <u>IDNR</u> website or by calling the IDNR Grants main line at 217-782-7481.

IDNR Snowmobile Trail Establishment Fund (STEF) Grant Program

The <u>STEF grant program</u> is offered annually and provides financial assistance up to 100 percent of eligible development/rehabilitation and equipment costs incurred by a local agency for approved projects that benefit public snowmobiling opportunities. The primary purpose is to provide financial aid to eligible private, not-for-profit snowmobile clubs to construct, maintain and rehabilitate snowmobile trails and facilities on public lands, designated roadways, or private land opened to such use in the state. STEF is a state-financed program with funds derived from snowmobile registration fees.

Safety

It's a danger that can happen to any driver - your car stalls or you get into an accident and your instincts tell you to get to safety. In traffic on a high-speed roadway, that's not outside your car. The Illinois Tollway is reminding drivers to stay in your car, activate your hazard lights and dial *999 for assistance.

Operations during COVID-19

The Illinois Tollway Board of Directors has continued to meet virtually each month to keep all business and construction activity moving and, as well as to advance significant tolling reforms reflecting their efforts to modernize our approach to unpaid tolls.

Services

In an effort to mitigate the spread of the coronavirus in the region, the Illinois Tollway continues to implement all-electronic tolling as a precaution to limit the potential spread of coronavirus to customers, as well as Tollway employees.

Mainline toll plazas, automatic toll payment machines and in-person customer service centers are currently offline. Toll collection is currently handled via I-PASS, E-ZPass and through the Tollway's website. The Tollway Customer Service Call Center is operational and assisting customers.

Traffic

Early in the year, pre-COVID-19 Tollway toll transaction rates were up year-over-year, but during the heart of the pandemic, transactions were off projected totals by 55-60 percent for passenger vehicles and off 15-20 percent for commercial vehicles.

As of August, commercial volume has somewhat stabilized nearly back to pre-COVID levels, while passenger traffic has also rebounded but is still volatile, about 20% below projections.

Employment

The Illinois Tollway values the diversity of its workforce and continually strives to improve access to employment opportunities. To ensure we are capable of continuing to provide service to our customers, the Illinois Tollway is advertising and hiring new employees for a variety of positions.

Reform and Relief

In an effort to realign the way customers interact with the Illinois Tollway, the agency has launched the first in a series of improvements to ensure the Illinois Tollway system works for everyone. *The TOLLING 2020* package includes:

• Vehicle owners across all vehicle classes will now receive an invoice for unpaid tolls with an initial fee that better aligns with the underlying tolls associated with the class of vehicle. Passenger vehicles will see an 85 percent reduction in initial costs, with a \$3 invoice fee, rather than a \$20 fine for each unpaid toll.

• As of July, toll violation fines in existing notices prior to March 9, 2020, have been reduced to \$3 across the board through the end of the year to provide customers an opportunity to pay their fines at a significantly reduced rate. This includes anyone previously sent to collections for outstanding toll violations.

Construction

The Tollway is proceeding with all construction projects as well as roadway maintenance and repair work systemwide. With safety as a top priority, the agency has worked closely with contractors to ensure the proper safety precautions have been taken to protect workers engaged in outdoor construction activities along our system.

Tollway contractors and consultants continuing their work are always required to have comprehensive safety plans in place, and those plans have been updated to account for the safety precautions during the COVID-19 pandemic.

Something new to highlight - A Central Tri-State Tollway (I-294) Project Virtual Open House is now available on the Tollway's website to share 2020 construction information, as well as highlight key features and provide an overview of the \$4 billion project's benefits and improvements safely and conveniently with the public. The Virtual Open House offers the opportunity "walk through" a room to view informational displays, maps, construction cameras and videos highlighting work currently underway and throughout the duration of construction.

Northwest construction projects:

- I-490 Tollway Project includes interchange construction for ramps to westbound I-90, the I-490 bridge that will carry traffic over the Touhy Avenue Reservoir and collector-distributor roads along I-90.
- Central Tri-State Tollway (I-294) Project mainline roadway construction and widening continues between the O'Hare Oasis and North Avenue. Additional bridge sewer and ramp work is underway throughout the rest of the corridor to prepare for mainline work.

Pace Welcomes New Board Member, Hoffman Estate's Mayor William D. McLeod *McLeod fills Northwest Suburban Cook County seat left vacant by Al Larson's retirement*

ARLINGTON HEIGHTS, IL – On August 1, former President of the Village of Schaumburg Al Larson, retired from the Pace Board of Directors after 20 years of service to the public transportation agency. Larson served Schaumburg as Village President from 1987 to 2019 and has held many roles as a public servant, including President of the Northwest Municipal Conference, Vice President of the Illinois Municipal League, and a Board Member for the Chicago Metropolitan Agency for Planning (CMAP).

On Wednesday, July 29, the Cook County Suburban Caucus held a virtual meeting and appointed Mayor William McLeod of Hoffman Estates to replace Al Larson. McLeod was elected to the office of Mayor in April 2001, after serving as Acting Mayor from September 2000 and Village Trustee since 1980. During his tenure, Mayor McLeod has dedicated himself to the growth and sustainability of Hoffman Estates in the areas of economic development and business retention, housing, infrastructure, and transportation. He helped spearhead and guide the development of the highly visible Barrington Interchange, which is home Illinois' first in-line (on-highway) bus station and Pace's I-90 / Barrington Road Park-n-Ride.

"We are grateful for Al Larson's many years of dedicated service. He was Schaumburg's biggest supporter and was an integral part of Pace's leadership team," said Pace Chairman Rick Kwasneski. "Mayor McLeod is a welcome addition to our Board. His partnership was key in the success of Pace's I-90 Market Expansion project and I look forward to seeing what else we'll achieve together."

The Illinois statute that established the regional transit structure dictates that Pace's Board is to be comprised of 13 members, all of whom are current or former mayors with the exception of the City of Chicago's Commissioner of the Mayor's Office for People with Disabilities, who serves on an ex-officio basis but has full voting rights. Each member represents a defined territory within Cook County or one of the five collar counties.

Dear Pace Passenger,

As we continue with the phased and cautious reopening of our region, we recognize our responsibility to operate safely, serve a critical public need, and communicate transparently.

Our priority remains the safety of our passengers and personnel. Pace is a vital service that provides crucial transportation access for the communities we serve, including transportation for many essential workers traveling to and from their places of employment. We take that responsibility seriously and will continue do our part to prevent the spread of COVID-19.

Effective 12:01 a.m. on Monday, June 22, we will end our temporary suspension of fare collection and return to front door boarding only. Riders will be required to pay fares on all Pace bus routes, On Demand services, Dial-a-Rides, and ADA Paratransit services. To support efforts to continue to schedule single-passenger ADA Paratransit trips as ridership allows, we will waive fares on City of Chicago Taxi Access Program (TAP) trips until further notice. Fares for medical personnel continue to be waived as well.

All service suspensions remain in effect. We will monitor demand and be prepared to reintroduce services as resources allow and people return to work and regular activities.

We will continue to:

- Prioritize the safety of our passengers and personnel
- Deep clean and sanitize vehicles daily
- Clean high touch surfaces throughout the day
- Provide operators with PPE
- Limit seating where possible to encourage social distancing
- Keep indoor spaces closed
- Limit on board passengers and add extra vehicles to routes as we are able
- Temporarily waive TAP fares and fares for medical personnel

Please do your part to prevent the spread of COVID-19 (coronavirus):

- Wear a facemask on Pace buses (per **Executive Order 2020-32**)
- Wash your hands, cover your cough, don't touch your face, and stay home if you are sick
- Give operators and other riders space; board and take your seat promptly

- Reconsider unnecessary travel
- Use your Ventra Card to pay fares quickly and limit crowding at the front of the bus
- Check if service is running regularly on your route
- Ride with a personal care attendant if you need physical assistance
